That is not the case and would be illegal. It may be that he is endorsed by the Puyallup Police Association which is a private organization made up of a subset of police officers on a committee.</p> <hr/> <p><u>Chris Chisholm</u> <i>(Wed, 7 Jul 2021 at 11:55 AM)</i></p> <p>Additional information discovered yesterday: In the smallest, lightest gray type, "ASSOC." appears inside the "E" of "Police" which is unreadable in all of the candidate's online photos, to all driving by, and even anyone walking by. I didn't notice it until I took a close-up photo of the sign yesterday and somehow managed to see it inside the "E" indicating the candidate knew he was being deceptive, rather than simply unaware of the difference between the Puyallup Police Department and the Puyallup Police Association. See attached photo and look inside the "E" -</p>
