Dear Mr. Angina,

Enclosed is a document dated 7/21/2021 designating me as a contributor to the "Washingtonians to Recall Inslee" group in the amount of \$1230.00 At no time, did I make this contribution. The following is the chain of events that led C Davis and Alexis Wallace to falsify this so-called contribution

On May 17, 2021, there was a rally at the area near the Board of Elections office in Olympia. It was well attended, a large crowd. C Davis drives a big white van, within it are recall Inslee signs of 3 different sizes, 12x24, 24x48, and 48x96. Bumper stickers, and T shirts of various sizes, S, M, L, XL, 1X, 2X, 4X, and 6X. If there were sizes not mentioned, I did not see them. C Davis's van is a jumbled mess, finding anything wasn't easy.

I was designated as the "store keeper" Selling signs, T shirts, and bumper stickers. There was no table available to assist with record keeping, no forms, no pens, no paper, not even a secure money holder. A woman buying merchandise gave me a green make up type bag to put money in, nothing at all was provided by C Davis, nor Alexis Wallace. To make it worse, the parking lot we were to be in, was unacceptable. A supervisor of the building next to the Board of Elections came out and asked us to move. So, we had to put the merchandise on the ground, in unmarked boxes over the dividing curb. C Davis and Alexis Wallace knew we weren't supposed to set up in the original lot, but they never said a word.

Despite working off the ground, the store was doing pretty good. I was doing my best to keep up with the names of the people buying items. It got so busy, keeping up with a borrowed pen and a piece of paper became untenable. Three times, Alexis Wallace came up to me with a lot of cash, a lot. She said, I sold some signs and T shirts. There was no record of the buyer's names, just cash. There was something close to \$1,230.00 of sold items without names of the buyers, or "contributors" as they are

referred to by C Davis. After the rally, I personally informed C Davis of the amount for which I had no "contributors" listed, and why. I do know it was less than \$1230.

C Davis launched into this tirade about how this very thing brought Tim Eyman down, on and on it went. Alexis Wallace, who was a big part of the anonymous contributions, never said a word and did not acknowledge her part.

C Davis then said "I will have to list you (meaning me) as the contributor of the money without names of the contributors. I said, "I would never contribute that much. C Davis said he was going to anyway because of Tim Eyman. I then said, I don't care.

In hindsight, I probably should not have said "I don't care" but I was so fed up with the day, the disorganization, of which Alexis Wallace played a part, C Davis's tirade at me, and to make it worse, he spoke freely to others, still blaming me. I have the names of two witnesses that will testify to the day's events.

In summary, I never made the \$1,230 contribution to Washingtonians to Recall Inslee. C Davis listed me as a ruse to make himself look legitimate. The most I ever contributed was, on a different day, I bought 2 T Shirts and a 24x48 sign. Period. That totaled \$110.

Again, I have enclosed the PDC form listing me as a contributor. C Davis and Alexis Wallace have knowingly falsified this document. Mr. Angina, whatever it takes to remove me from this false monetary contribution form I would appreciate it. Please feel free to share this letter with C Davis and Alexis Wallace. I, unlike them, have nothing to hide
