You are receiving this email because you **live in Burien**, **work or own a business here** or are **other-wise invested by shopping or dining in our community**. Burien United is a nonpartisan, grassroots group of concerned citizens who have joined forces because we are very worried about our city's future, given recent the recent votes of our City Council. The goal of this correspondence is to keep you informed of our upcoming City Council elections and to engage you with the issues at hand.

Last year, while all of us were concentrating on staying safe, stressed about the health and well being of our families and worried about our job security, Burien's City Council quietly voted to approve two major projects, DESC and ESFs. Both of these undertakings will forever change the land-scape of our community and reshape Burien into King County's dumping ground. Burien's homelessness and crime are complex problems, and we need to solve these issues in Burien before we consider inheriting King County's. We must have a City Council who will transparently focus on the needs of our community, and listen to our voices while addressing these issues. As you are probably already aware, our current City Council has approved:

#1. **DESC** (Downtown Emergency Services Center)

A 95-unit residential homeless shelter to be placed near 150th and Ambaum, very close to the downtown retail core. This property will house homeless from all over King County, not just Burien's homeless population. Drug use will be allowed in this facility. **DESC will essentially warehouse these individuals in need, with no support services, job training or rehabilitation offered.** This project & the associated crime have the potential to drive out restaurants & businesses, permanently destroying our downtown while at the same time not paying any taxes to our city.

#2. ESF (Enhanced Services Facilities)

An ESF was originally proposed to go in by St. Francis in 2019 and the community successfully stopped that proposal. Despite the outcry, the City Council still voted in 2020 to permit ESFs in any area of Burien including all residential neighborhoods. Per the City of Burien's website "Enhanced Services Facilities are licensed residential facilities that provide a community placement option for individuals whose complicated personal care and behavioral challenges do not rise to a level that requires an institutional setting." The Department of Corrections and other agencies are now exploring placing multiple facilities in Burien. There are no restrictions to location in our community, while cities like Des Moines and Shoreline have limited where ESF's can be placed. Facilities near schools, daycares, and in any residential neighborhood are allowed.

To fight this current trajectory, we must vote for a new Burien City Council that will prioritize our city's safety and vibrancy. We need a City Council that represents us and protects our interests. Please consider voting for these candidates (and donating if you are able) as they have Burien's best interest at heart.
