The candidate's campaign has not responded to a request for inspection of campaign books of account. He has not responded in any way to the initial inquiry, which proposed a time within the inspection period, and prior to the "best efforts" safe harbor. He has not proposed an alternative time/place where inspection might occur, or otherwise made any attempt to open his books for inspection. His social media indicate a contribution of \$200 which has not been deposited within the 5 business day timeframe. He or others on his behalf have made expenditures supporting his campaign, as evidenced by the presence of campaign signage in various parts of the city, and his own social media posts. This supports the existence of expenditures, and the necessity to have records.

I will not be beholden to anyone but the Voters.


