Subject: Siabhon Ayuso, PDC Case Number 97281

The Public Disclosure Commission (PDC) is investigating a complaint filed on August 4, 2021, by Tom Perry. The complaint alleges that you, Siabhon Ayuso, a candidate for Lakewood City Council in the 2021 election year, may have violated RCW 42.17A.235 and .240 for failure to timely and accurately file Monetary Contribution (C-3) and Summary Full Campaign Contribution and Expenditure reports (C-4) reports, disclosing contributions and expenditures undertaken by the Campaign.

In accordance with RCW 42.17A.110 and RCW 42.17A.755, a Brief Adjudicative Proceeding (Brief Enforcement Hearing) has been scheduled to determine if you, Siabhon Ayuso, violated RCW 42.17A.235 and .240 by failing to file C-3 and C-4 reports in the 2021 election cycle. Under the Brief Enforcement Hearing rules, the Presiding Officer has the authority to assess a civil penalty in accordance with the penalty schedule adopted by the Commission – WAC 390-37-143. A copy of the penalty schedule is enclosed/attached.
