<p><u><a href="#">Brigid Nelson</a></u> reported via the portal (Wed, 18 Aug 2021 at 10:37 AM)</p> <p>I'm writing in regards to Misipati Semi Bird's campaign for School Director, Richland School District 400, Position 3. As of at least August 12, 2021 Misipati Semi Bird's contributions on the PDC site are shown to be \$7861.02. Mr. Bird's report filing is shown to still be a 'mini-reporting' with a \$5000 limit on contributions. Mr. Bird appears to be in violation of the contribution cap by at least \$2801.02. Mr. Bird appears to have not disclosed any of his campaign contributions or expenditures, as would be expected if he was a full-reporting candidate or in process of switching to full-reporting. I would like to file a formal complaint for violation of contribution limits.</p> <p>letter of intent.jpg 2.3 MB</p>
<b>What impact does the alleged violation(s) have on the public?</b>
Providing no contribution or expense reports means that voters can't know whether funds are gained or used appropriately. Accountability is bypassed.


