Subject: Complaint regarding Christian Leonard, PDC Case 98589

Dear Mr. Edwards:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on September 14, 2021. Your complaint alleged that Christian Leonard, a 2018 candidate for Spokane County Assessor, may have violated RCW 42.17A.235 and .240 for failure to timely and accurately report expenditure descriptions for political advertisements undertaken by his 2018 Campaign for Spokane County Assessor.

PDC staff reviewed your allegation; the applicable statutes, rule(s), and the reporting requirements; the Summary Full Report Receipt and Expenditure (C4) reports filed by Christian Leonard For Assessor (Campaign); and the September 22, 2021, response to the complaint provided by Christian Leonard, on behalf of the Campaign.

Based on staff's review, we found the following:

- On March 3, 2018, Christian Leonard timely filed a Candidate Registration (C-1) report and selected the Full Reporting Option.
- The complaint alleged that the Campaign failed to timely and accurately disclose expenditure descriptions for political advertisements. Specifically, the complaint alleged that the Campaign failed to provide the required expenditure description for two Robocalls totaling \$1,001.34 and a \$187 newspaper that were disclosed on the amended 2018 7-Day Pre-General Election C-4 report.
- Staff reviewed the C-4 reports filed by the Campaign and found that the Campaign failed to provide the required descriptions for the two items noted supra (two Robocalls and a Newspaper Ad), that were disclosed on the amended 2018 7-Day Pre-General Election C-4 report.
- On September 29, 2021, the Campaign amended eight C-4 reports and provided the required descriptions for all Robocalls and Newspaper Ads, as required by the statutory scheme.

Based on our findings, staff has determined that, in this instance, failure to provide the required descriptions does not amount to a violation that warrants further investigation. The Campaign was responsive and amended

the pertinent reports as soon as the deficiency in the expenditure description requirement was brought to their attention.

Christian Leonard made a minor or ministerial errors on required reports, which did not materially impact the public interest. Upon notification of these errors, Christian Leonard timely amended his reports, making the necessary technical corrections as requested by staff.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
