As Treasurer for the Whatcom County Republican Party I take full responsibility for the accuracy and any errors that may have occurred in preparing the required reports. As a volunteer I perform these duties without pay and keep a busy schedule between employment, community, and family responsibilities. Everyone that knows me can attest to my integrity. Having served as finance clerk for my church congregation for over five years I had perfect or near perfect audits every six months. Any errors can be attributed to simply being overly busy and distracted. To end the 2020 year the party reorganized and elected a new slate of officers. I was the only returning officer and some of our accounting processes have been refined to eliminate the type of errors found at the close of 2020. I will respond to the allegations by Mr. Raas in the following paragraphs.

- (1.) I mistakenly entered the checks written to Lithtex Printing in the amount of \$8,024.80 twice. These were reported as Independent Expenditures using the online portal and then entered into ORCA, causing a duplicate entry. There were no additional contributions to the party beyond what has been reported. I have not audited the books for 2020 therefore cannot speak to the additional discrepancies found by Mr. Raas other than to say that they were caused by overreporting and not underreporting.
- (2-5.) Were all caused by a bug in the ORCA software that I found when entering the auction reports following our Lincoln Day Dinner fundraiser. These errors were reported to the PDC and since the duplicate reports did not show up in my ORCA portal the PDC had to delete them for me. All donors of silent auction items had their contributions multiplied by a factor of six. I contacted the PDC about this issue on May 24, 2021 and it was resolved on June 3, 2021. I have attached copies of the email correspondence with the PDC for the record.

That could cause your ORCA campaign to not show that these documents were submitted. Another way that this could happen is if you used the clear filing history function in ORCA, which the system advises filers not to do unless instructed to do so by the Public Disclosure Commission. Please let me know if you did either of these things, and what the correct document numbers are for the last two documents in the list that you sent me.

We recommend that you use the name of the campaign and the date that you made the backup, without slash marks, something like Whatcom Co Repub 5-24-2021 That window has a file directory on it so that you can tell the software where to put your backup.
