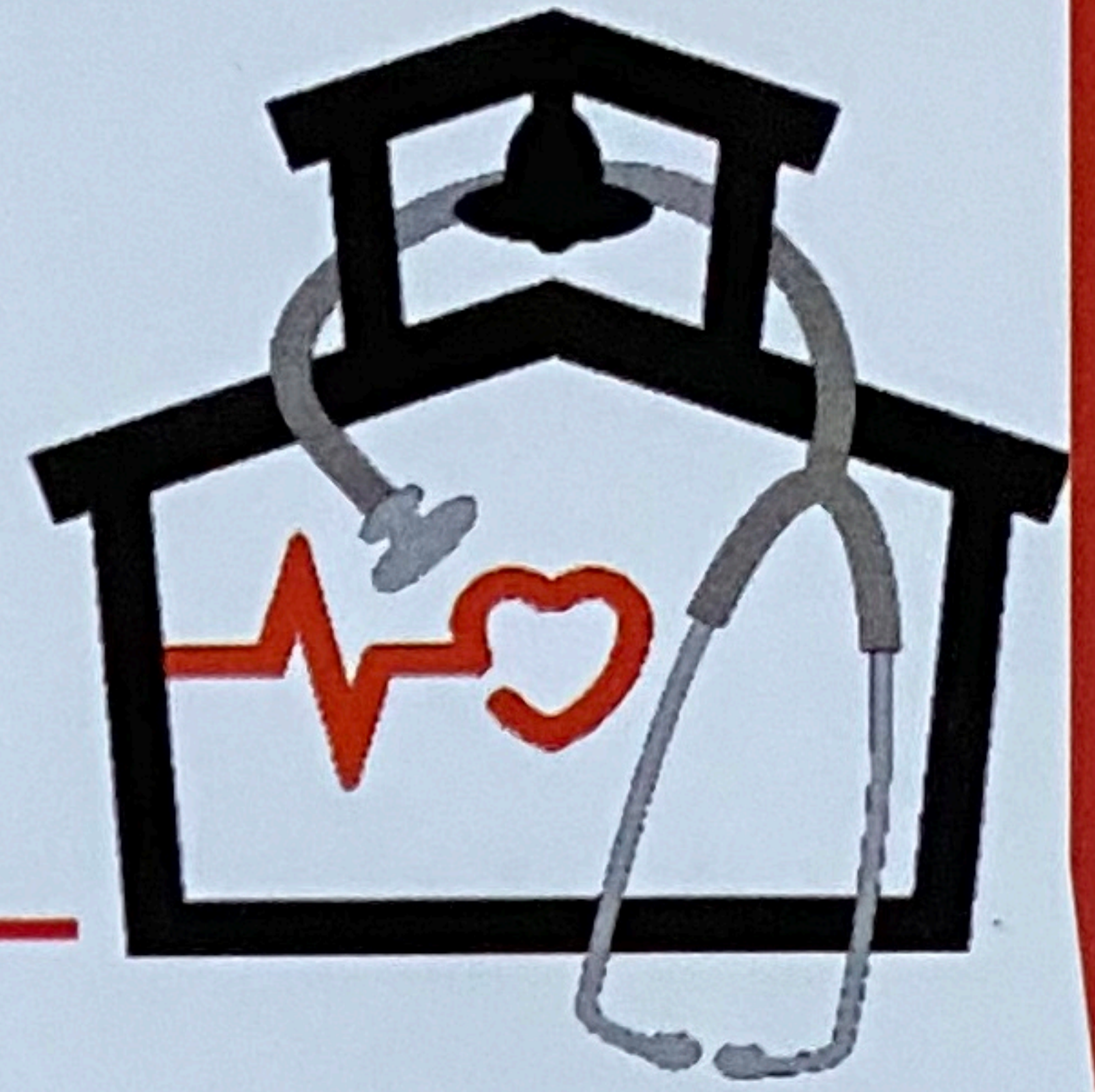

Three candidates for school board positions were in attendance: Pam Orebaugh, Rob Linebarger and Bret Howell. Both Pam and Bret brought yard signs, flyers, and stickers to give out. As I was leaving the event I picked up a flyer from Pam. The flyer does not indicate who paid for the flyer or the address of the sponsoring party—violating RCW 42.17A.320, which states, "(1) All written political advertising, whether relating to candidates or ballot propositions, shall include the sponsor's name and address."</p> <p>There is a similar complaint open regarding a different flyer promoting Pam, Bret and WA Citizens for Liberty in which the sponsoring party is not identified (Case #99327). The respondent in that case is WA Citizens for Liberty. Both Pam Orebaugh and Rob Linebarger sit on the board of WA Citizens for Liberty. Pam has responded to Case #99327 as it relates to her campaign and indicated that Rob and the attorney for WA Citizens for Liberty, Grant Wolf, will respond from their nonprofit. The fact she has responded to a nearly identical complaint indicates that she is aware of the law yet continues to violate it.</p>
<b>What impact does the alleged violation(s) have on the public?</b>
The public is unaware of who sponsored the printing of the material being distributed to voters.
