#### **Complaint Description**

Steve Freeman reported via the portal (*Thu, 21 Oct 2021 at 1:50 PM*)

In the attached electioneering political advertisement, the Top 5 contributors fail to list Lisa Brown for Congress.

According to the 509 Forward's PDC cash receipts C3 form, Lisa Brown for Congress made a contribution to the committee on 10/8/2021 in the amount of \$9,500.

On 509 Forward's independent expenditure ads C6 form, it lists an expense for a mailer supporting Naghmana Sherazi for Spokane City Council an Opposing Jonathan Bingle for Spokane City Council dated 10/14/2021.

In addition to failing to disclose Lisa Brown for Congress in the Top 5 contributors disclaimer, as a PAC entity, the sponsors should have also disclosed the Top 3 donors to Lisa Brown for Congress.

According to the PDC website's Political Advertising Guide:

A political committee must include its Top 5 contributors' names when sponsoring an ad about a ballot measure with a cost of at least \$1,000 in the aggregate, or when making an independent expenditure for or against a candidate. If the Top 5 includes any political committees, the sponsor must also list the Top 3 donors to the political committees.\* The Top 3 donors to PAC contributors must be three individuals or entities other than political committees.

The sponsor determines the Top 5 and Top 3 lists by considering the largest contributors who gave at least \$1,000\* during the 12 months before the ad appears. In the case of a tie among the top contributors, meaning multiple contributors have given the same amount, the political committee sponsor may choose which will be named. \*Effective July 28, 2019

#### What impact does the alleged violation(s) have on the public?

Without disclosure and transparency, Spokane voters have little idea who is trying to influence their vote, making it difficult to make an informed choice for City Council. This specific situation has the appearance of dark money coming into Spokane politics. In this case, it appears perpetrated by political operatives – including an appointed state official who should have a clear understanding of the laws and know better than to take part in these actions. To say nothing of the fact that her husband, top advisor to the very Council President that endorsed Naghmana Sherazi, would benefit from the outcome of this election.

If true, that would be a significant breach of the public trust.
