<b>Complaint Description</b>
<p><b><u>Sylvia Schultz</u></b>  <i>(Thu, 28 Oct 2021 at 9:09 PM)</i></p> <p>A report filed on 7/13/2021 by Christopher Roberdeau and Conner Edwards, an experienced treasurer, for a 6/8/2021 loan valued at \$474.54 as an in-kind contribution appears to not have been properly described as an expenditure for political advertising. Similarly, a report filed on 7/13/2021 by Angela Louise Chapman and treasurer Conner Edwards for a 6/8/2021 loan valued at \$474.54 as an in-kind contribution appears to not have been properly described as an expenditure for political advertising. As the loans were arranged between each campaign and Dominique France, the transactions appear to be required to meet disclosure requirements for a contribution and as an expenditure. Yard signs and business cards and the quantities of each are campaign assets that may carry forward to benefit a candidate in a general election. In addition, the nondisclosure by the Chapman campaign of the employer and occupation of Dominique France for the \$474.54 loan does not appear to meet disclosure requirements.</p>
<b>What impact does the alleged violation(s) have on the public?</b>
The public is unable to ascertain the benefit the campaigns and the lender received from the transaction or to evaluate the reasonableness of the fair market valuation and loan terms.

On May 19, 2021, Christopher Roberdeau (Committee to Elect Chris Roberdeau) filed registration for candidacy for school director position 4, Northshore School District 417, and designated Conner Edwards as treasurer (Attachment 1).

During the course of the election, the Roberdeau campaign reported it received contributions, expended funds, and incurred debts, including on a C4 report signed on 7/13/2021 by treasurer Conner Edwards and candidate Christopher Roberdeau:

The 7/13/2021 Roberdeau campaign report described the \$474.54 amount as an "In-Kind Loan" under "monetary or in-kind loan received." As reported, the loan was not in cash, but an in-kind contribution to the campaign. However, the Roberdeau campaign did not describe the nature of the property or services received.

On May 21, 2021, Angela Louise Chapman (Friends Of Angela Chapman) filed registration for candidacy for school director position 5, Northshore School District 417, and designated Conner Edwards as treasurer (Attachment 3).

During the course of the election, the Chapman campaign reported it received contributions, expended funds, and incurred debts, including on a C4 report signed on 7/13/2021 by treasurer Conner Edwards and candidate Angela Louise Chapman:

The 7/13/2021 Chapman campaign report described the \$474.54 amount as an “In-Kind Loan” under “monetary or in-kind loan received.” As reported, the loan was not in cash, but an in-kind contribution to the campaign. However, the Chapman campaign did not describe the nature of the property or services received. The 7/13/2021 report from the Chapman campaign did not disclose the name of the contributor’s employer and occupation or of the lender’s employer and occupation.

On May 27, 2021, Ekaterina Bautista registered for candidacy as Katya Bautista for Northshore School Board for school director position 4, Northshore School District 417, and designated Tom Perry as treasurer (Attachment 5).

During the course of the election, the Bautista campaign (filing under the name “Katsiaryna Bautista”) reported it received contributions, expended funds, and incurred debts, including on a C4 report signed on 7/13/2021 by treasurer Tom Perry and candidate Katsiaryna Bautista:

The 7/13/2021 Bautista campaign report described the \$474.54 loan as “Vistaprint: Yard signs (100), business cards” under “monetary or in-kind loan received.” As reported, the loan was not in cash, but in the form of yard signs and business cards for the campaign.

According to the candidates’ reports, on the date of the \$474.54 loans to the Roberdeau and Chapman campaigns, the same individual made a third loan for the same amount to the Bautista campaign. All three loans were described as “in-kind loans.” Only the report from the Bautista campaign described the property the candidate received as an in-kind contribution, which for reporting purposes is also treated as an expenditure.

From existing reports filed with PDC, it cannot be known what property or services valued at \$474.54 were received by the Roberdeau and Chapman campaigns as an in-kind loan from Dominique France on 6/8/2021. In addition, the 7/13/2021 filing from the Chapman campaign does not disclose information required for the contributor’s employer and occupation and for the lender’s employer and occupation

#### PDC Committee Registration:

Subsequent to the loan of a non-cash in-kind contribution to the Roberdeau campaign, a continuing committee called Students First was registered on 9/18/2021. Dominique France and Angela Chapman were listed as officers and Melissa Wells as treasurer (Attachment 7).

#### PDC Contribution Records:

“France Dominique” - nine records of contributions, including three in-kind contributions (described above), an in-kind contribution to Students First, and five cash contributions to Northshore School District 417 school director candidates Christopher Roberdeau, Amy Felt, Angela Louise Chapman, Michael Albrecht, and Katsiaryna Bautista (Attachment 8)

“Chapman Angela” - two records of cash contributions: Students First for \$250 and Snohomish County Republican Central Committee for \$966.54 (Attachment 9)

#### PDC Treasurer Compensation Records:

“Edwards Conner” – 102 records of payments, including from King County Republican Central Committee, Thurston County Republican Central Committee, Tim D. Eyman, James “JT” Wilcox III, Michael Albrecht, and Angela Louise Chapman (Attachment 10)

“Conner Edwards” – 5 records of payments of which 4 are from Christopher Roberdeau for a total of \$800 (Attachment 11)

#### Relevant Law:

Each report must be certified by the candidate and the treasurer and “shall” disclose contributions and expenditures and other information required by the commission, per [RCW 42.17A.240](#).

A loan is included in the definitions of (15) “Contribution” and (22) “Expenditure” specified in [RCW 42.17A.005](#).

Further definition of contribution as it relates to the financing by a person of “political advertising” is described in [WAC 390-05-210](#)(2).

Expenditures made “on behalf of a candidate...by any person” who is “employed or retained” for the purpose of organizing, directing, managing or assisting” the candidate shall be reported “as if” made or incurred by the candidate directly, per [WAC 390-16-205](#)(1).

According to [WAC 390-16-037](#)(2) “Whenever an expenditure is made to a candidate or a political committee pursuant to an agreement or understanding of any kind regarding how the recipient will use the expenditure, the report must describe in detail that agreement or understanding and the goods and/or services to be provided.” The regulation provides examples of details to include in a report: “Vendor Name”, “Purpose”, and “Amount”.

A loan to a candidate for public office “must be by written agreement” according to [RCW 42.17A.465\(2\)](#).

A report filed by candidate or political committee “shall disclose” the occupation and employer’s name and address of each person who has “made one or more contributions in the aggregate amount of more than one hundred dollars”, per [WAC 390-16-034](#).
