Complaint Description
<p><u>Sylvia Schultz</u> <i>(Tue, 2 Nov 2021 at 4:57 AM)</i></p> <p>A review of reports filed by Students First which has two officers, Dominique France and Angela Chapman, and treasurer Melissa Wells, appears to not have filed a C6 disclosure report for a \$19,055.23 independent expenditure to send a postcard advocating for candidates. In addition, a report did not disclose the employer and occupation of a school board candidate who ran during the primary, Katsiaryna (Katya) Bautista, although she had given over \$100 in the aggregate after the primary to Students First. Other records appear to lack sufficient detail with respect to services provided and quantities of each item. Lastly, the website published the committee's top donors, but the disclosure appears incorrect and incomplete.</p>
What impact does the alleged violation(s) have on the public?
<p>Disclosure of independent expenditures in a school board race defends one of the great foundations of democracy: public education. The public is choosing who they will entrust with the support and management of the public schools. Lacking plain disclosure of a committee's direct advocacy for candidates may taint the integrity of the election. The disclosure rules are complex but even leaders of a new committee and a new treasurer are responsible for following them. There are few limits in Washington election law; it is all about letting the public know what the candidates and the committees are doing. These rules of disclosure give us confidence in our elected officials and defend a level playing field where ideas and debate can flourish in fairness and integrity.</p>

Students First filed to register as a continuing political committee on 9/18/2021 with two officers, Dominique France and Angela Chapman, who designated Melissa Wells as treasurer (Attachment 1).

Occupation & Employer of Contributor Not disclosed

During the course of the election, Students First reported it received contributions and expended funds. It reported no debts. Reports of C3 contributor records were signed by treasurer Melissa Wells (Attachment 2).

The 10/21/2021 C3 filing above does not disclose the contributor's occupation and employer's name of Katsiaryna (Katya) Bautista who contributed over \$100 in the aggregate.

Incomplete Detail in Expenditure Records

C4 expenditure reports were signed by treasurer Melissa Wells. On 10/11/2021, Students First submitted its first C4 expenditure report (corrected filings submitted 10/21/2021 and 10/30/2021, Attachment 5). The 10/11/2021 report included the following records:

Date Paid: 10/07/21; Vendor or Recipient: VISTA PRINT, 170 Data Drive, Waltham, MA 02451; Purpose of Expense and/or Description: Postage costs, mail permits, purchase of stamps; Amount: \$539.26

The 9/27/2021 record and the 10/7/2021 record appear to lack sufficient detail with respect to services provided and quantities of each item.

9/27/2021 Postcard Expenditure

Students First's largest reported expenditure was for a "Postcard/Postage" expense from CRS Printing in Kalamazoo, MI on 9/27/2021 for \$19,055.23. The description does not state the quantity of printing and postage. Students First reported no other expenses specific to printing a postcard.

On 10/18/2021, I, the complainant, received a Students First postcard in my mailbox (Attachments 6a, 6b, 6c). The two-sided postcard measured 5.5 inches by 8.75 inches. The expenditure from CRS Printing appears to have resulted in the design, printing, and mailing of the postcard that I received.

Side 1 of the postcard displays photos of three candidates for the Northshore School Board: Elizabeth Crowley, Chris Roberdeau, and Amy Felt. Each photo is labeled with their full name. In addition, side 1 displays the messages "VOTE NOVEMBER 2 FELT, CROWLEY, ROBERDEAU" and "Elect **current NSD Parents** with a **VESTED** interest to the Board" and "YOUR VOTE MATTERS" (emphasis and red font in original).

Side 2 displays "**STUDENTS FIRST** VOTE FOR OUR KIDS". Printed on the lower edge is a small circular logo of a mortarboard cap image with the words "STUDENTS FIRST VOTE FOR OUR FUTURE" ringing the image. Beside the round logo are the words, "IT'S TIME FOR **STUDENTS FIRST** IN NORTHSORE" (emphasis in original).

A "paid for by" sponsor identification statement on side 2 states:

No candidate authorized this ad. Paid for by Students First (Po Box 2718, Woodinville, WA 98072). Top 5 Contributors: Tom Neider, Peter Zieve.

At the time of the postcard, Students First did not have more than two donors who had given \$1,000 or more. The sponsor identification statement font size appears smaller than 10-point font. (Attachment 6c).

On the postcard's side 2, in the upper right is a QR code for "www.nsdvote.com" that opens the website <https://www.nsdvote.com/> (see below). A presort imprint shows it was "PAID" by a permit holder in Michigan, "**Kalamazoo, MI Permit No. 380 19 - 29639**" (emphasis added). The website for CRS Printing,

Kalamazoo, Michigan, <https://crsprinting.com/other-services.html>, states it is a “one-stop solution to all of your print fulfillment, marketing, and direct mail campaign needs.”

Website www.nsdvote.com

The Students First website, www.nsdvote.com, displays multiple images of the circular logo (seen on the postcard, described above) and endorses Elizabeth Crowley, Amy Felt, and Chris Roberdeau in the Northshore School District director elections. The images of the endorsed candidates accompany their names. On the home page is a statement in red: **“VOTE FOR ALL 3 CANDIDATES”**. A “Donate” page promotes contributions to Students First by check, credit card, and wire transfer. An “Events” page includes promotion of a special education town hall on October 14 and proclaims, “Vote for Amy Felt, Chris Roberdeau and Elizabeth Crowley!”

According to DomainTools, the Students First website domain “nsdvote.com” was registered on Google on 8/30/2021 with a protected identity, “Contact Privacy Inc. Customer 12410971952” (Attachment 7). The domain was registered prior to Students First’s C1 registration on 9/18/2021.

According to PDC filings, Dmitry Grigorenko reported an in-kind independent contribution to the three candidates, Elizabeth Crowley, Chris Roberdeau, and Amy Felt, on 9/18/2021 with a fair market value of \$248.01 to Students First (Attachment 5, page 4). Mr. Grigorenko, who reported he was a “software engineer” with Facebook, on 9/16/2021 had filed a C6 independent expenditure report in which he evenly divided \$248.01 in-kind contribution to benefit the campaigns of Elizabeth Crowley, Chris Roberdeau, and Amy Felt. As a result, the three candidates each received an in-kind independent campaign contribution of \$82.67 was in the form of 1/3 of Mr. Grigorenko’s spending of \$140.92 for “Domain Names” and \$107.09 for “Stickers” (Attachment 8).

Students First has not reported an expenditure for website design nor filed a C6 to report the independent expenditure on behalf of the three candidates. A dedicated volunteer such as a software engineer may have designed the website, however then the committee may have been required to report the fair market value of professional website design services.

The website’s sponsor identification states:

No candidate authorized this website, nor provided any content. Content has been pulled from publicly available sources, including voter pamphlet guide and various websites. It is paid for by Students First (PO Box 2718, Woodinville, WA 98072) . Top 5 Contributors: Tom Neider, Peter Zieve, Dmitry Grigorenko, Larry Chapman (<https://www.nsdvote.com/> accessed 11/1/2021)

The website sponsor identification shows four donors. However, by October 1, Students First could fill all five slots, as here:

- 1) Tom Neider \$10,000, various dates, latest 9/30/2021;
- 2) Peter Zieve \$2,500 9/18/2021;
- 3) Jon Neider \$2,000 10/1/2021;

4) Snohomish County Republican Party \$2,000 10/12/2021; (add “top three” contributors to the party when any of “top five” is a political party)

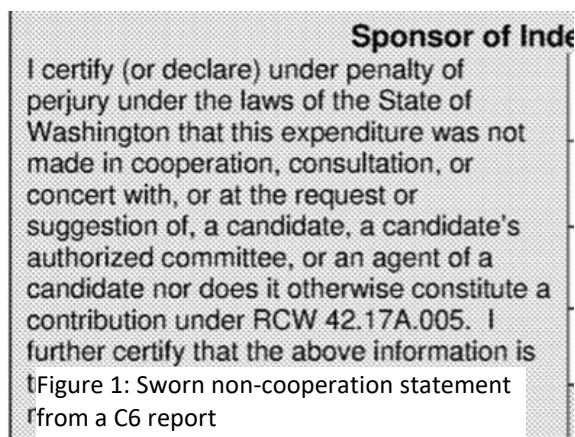
5) Dmitry Grigorenko \$1,248.01 various dates, latest 10/1/2021.

Independent Expenditures without C6 Reports

In 1972, the people of Washington voted 72.02% to 27.98% to approve Initiative 276 that established the Public Disclosure Commission. As the new law said, “our representative form of government is founded on a belief that those entrusted with the offices of government have nothing to fear from full public disclosure of their financial and business holdings.”

So, it is unusual to see a committee vigorously advocate for candidates in an election without disclosing C6 expenditures. The Students First postcard and website unambiguously identify Elizabeth Crowley, Chris Roberdeau, and Amy Felt as candidates backed by Students First, and plainly urge the public to vote for the three candidates. The postcard and website meet the definition of political advertisement for mass communication. The postcard was mailed and the website was designed within the 60 days before the election. The postcard expenditure was well over the \$1,000 threshold for reporting, although the only record for the website was Dmitry Grigorenko’s in-kind contribution of \$248.01. No C4 expenditure report for website design was filed.

By the sponsor statements, it appears Students First intended to be viewed as an independent



campaign. Students First has not filed C6 reports that contain a sworn statement of non-cooperation. There may be no PDC record that the committee’s expenditures are independent expenditures. Without disclosure, the public cannot be assured of the integrity of the election process or of these three races. Relying on public complaints to catch problems can allow a well-planned campaign to roll on through, especially in local, lower profile races.

Relevant Law:

Each report must be certified by the candidate and the treasurer and “shall” disclose contributions and expenditures and other information required by the commission, per [RCW 42.17A.240](#). Required disclosures include: “The name and address of each person to whom an expenditure was made in the aggregate amount of more than fifty dollars during the period covered by this report, the amount, date, and purpose of each expenditure, and the total sum of all expenditures.”

A report filed by candidate or political committee “shall disclose” the occupation and employer’s name and address of each person who has “made one or more contributions in the aggregate amount of more than one hundred dollars”, per [WAC 390-16-034](#).

For any person required to report expenditures, the purpose of the expenditure must be disclosed, according to [WAC 390-16-037](#)(1). Further, if the expenditure is pursuant to an agreement, the report “must describe in detail that agreement and the goods and/or services to be provided” and must include vendor, purpose (and number of items), and amount of expenditure, per [WAC 390-16-037](#)(2).

According to [WAC 390-16-205](#), independent expenditures to vendors and subvendors, as well as to consultants, must be disclosed. Expenditures made “on behalf of a candidate...by any person” who is “employed or retained” for the purpose of organizing, directing, managing or assisting” the candidate shall be reported “as if” made or incurred by the candidate directly.

[RCW 42.17A.255](#) and [RCW 42.17A.260](#) provide deadlines for reporting independent expenditures.

[RCW 42.17A.320](#), [RCW 42.17A.350](#), and [WAC 390-18-010](#) describe the “top five” contributors rule for sponsor statements, including the requirement that if a political committee, such as any party organization, is in the top five, the independent committee must publish the names of the political committee’s top three donors.

[WAC 390-05-210](#) and [WAC 390-05-235](#) define contributions and fair market value.

The political advertising definition for “mass communication” includes “fliers” under [WAC 390-05-290](#)(1)(b).

“All written political advertising, whether relating to candidates or ballot propositions, shall include the sponsor’s name and address” per [RCW 42.17A.320](#)(1). In addition, the required information shall be “set apart from any other printed matter” and at least “10-point type” according to [RCW 42.17A.320](#)(3)(c).

“All advertising must clearly state, in an area set apart from any other printed matter, that it has been paid for by the sponsor (Example: (1) Paid for by the XYZ committee, mailing address, city, state, zip code; (2) Vote for John Doe, paid for by John Doe, mailing address, city, state, zip code)”, as described by [WAC 390-18-010](#)(2), (emphasis added).

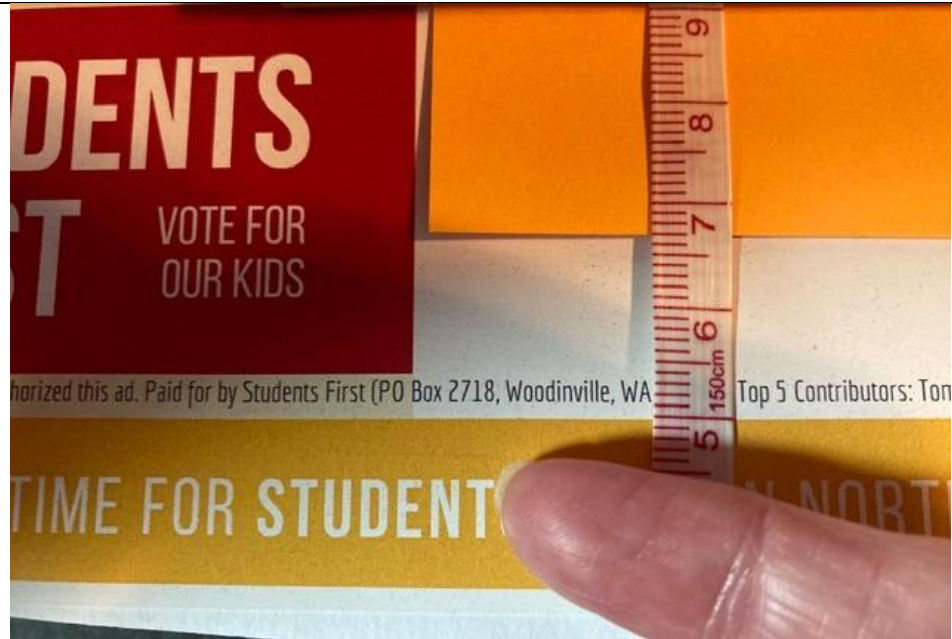
