### What impact does the alleged violation(s) have on the public?

A local ballot measure committee organized to oppose ballot measures on the 2021 November ballot. A website called "Just Vote No" advocated against seven measure amendments to the Clark County Charter on the general election ballot in 2021. Spent a considerable amount of money on campaign with no disclosure.

Voters don't have access to timely and accurate information about the financing of "Just Vote No" efforts because they are not registered with the Public Disclosure Commission as required by Washington State law. Nor is there paid for by or sponsored by listed on their website.

The campaign finance and disclosure laws rely on the antiseptic qualities of "sunshine" and several prohibitions to assure citizens of Washington that governmental systems and individuals who operate within it are open and honest.

Before deciding which ballot proposals deserve support, the law provides citizens with an indepth look at who is financing a campaign.

The public can't access this information because "Just Vote No" doesn't have a registered political committee.






