Subject: Joshua M Quantrell Enforcement Hearing Memorandum: PDC Case 102994

Allegations:

PDC staff alleges that Joshua M Quantrell, an incumbent Park & Recreation Commissioner for the Klickitat Recreation District, violated RCW 42.17A.700 by failing to file a Personal Financial Affairs Statement (F-1 report) for calendar year 2020, due not later than April 15, 2021.

Background and Prior Violations:

- Joshua M Quantrell was most recently elected Park & Recreation Commissioner for the Klickitat Recreation District in 2021. His current term end in 2025
- We have a single F-1 report in the system filed on August 22, 2017, covering August 22, 2016-August 21, 2017.
- The Respondent has two (2) prior violations within the statute of limitations.
- The Respondent currently has a balance of \$750 outstanding/unpaid on prior cases with the PDC.
- The balance of \$750 is currently in collections, with no payments showing made towards the balance, as of the date of this memo.
- The balance is made of penalties assessed on PDC cases 38893 (\$250, 2018) and 80230 (\$500 , 2021)
- The Respondent also has not filed calendar year 2017 (38893), 2018, 2019 (Case 80230).

First Violation (PDC Case 38893):

- The Respondent, who was a candidate for Parks & Recreation Commissioner in Klickitat Recreation District in 2018, failed to file an F-1 report for calendar year 2017, which was due no later than April 16, 2018.
- At a September 24, 2018 Brief Adjudicative Proceeding (Brief Enforcement Hearing), the Respondent was found in violation of RCW 42.17A.700 and assessed a \$250 penalty for failing to file an F-1 report that was due no later than April 16, 2018.
- To date, the Respondent has not paid the outstanding \$250 civil penalty for case 38893.
- In addition, the missing F-1 report for calendar year 2017 has not been filed.

Second Violation (PDC Case 80230):

- The Respondent, who was an elected Parks & Recreation Commissioner for Klickitat Recreation District in 2019, failed to file F-1 reports for calendar year 2018 and calendar year 2019, which were due no later than April 15, 2019 and April 15, 2020 respectively.
- At a March 8 Brief Adjudicative Proceeding (Brief Enforcement Hearing), the Respondent was found in violation of RCW 42.17A.700 and assessed a \$500 penalty for failing to file an F-1 report that was due no later than April 16, 2020.
- To date, the Respondent has not paid the outstanding \$500 civil penalty for case 80285.
- In addition, the missing F-1 report for calendar year 2018 and 2019 has not been filed.

Staff Recommendation:

Staff recommends the Commission find that Joshua M Quantrell violated 42.17A.700 by failing to timely file an F-1 report for calendar year 2020, and:

1. Assess Joshua M Quantrell a \$2,000 civil penalty recommended in accordance with WAC 390-37-182 for an individual with two prior violations, which is payable within 30 days of the date of the Order.
2. Require Joshua M Quantrell to file the missing F-1 report for calendar year 2020 within 30 days of the date of the Order.
