Enclosed is a copy of the Public Disclosure Commission's Order Imposing Fine that was entered in the above-referenced case.

At the August 25, 2022 Enforcement hearing, the Commission assessed a total civil penalty of \$500, of which \$500 is suspended, in accordance with WAC 390-37-182. if the conditions of the Order are met within 30 days of the date of this Order, which is **October 24, 2022**.

It is ordered that you file the missing F-1 reports disclosing financial information for 2020 and 2021 within 30 days of this order, which is **October 24, 2022**. Your F-1 report for 2022 can be filed within 60 days of leaving office and is due no later than April 15, 2023.

15 This matter was heard remotely by the Washington State Public Disclosure Commission
16 (Commission) on August 25, 2022, by telephonic and online streaming access. Respondent
17 Richard De Gloria was provided notice on August 11, 2022 of the hearing date. The hearing
18 was held in accordance with Chapters 34.05 and 42.17A RCW, and Chapter 390-37 WAC.

19 Commissioners present both telephonically and online were Fred Jarrett, Commission
20 Chair (presiding); Nancy Isserlis, Commission Vice-Chair; and Commissioners William
21 Downing, Allen Hayward, and Jocelyn Cooney. Also present both telephonically and online
22 were Assistant Attorney General John S. Meader representing the Commission, Assistant
23 Attorney General Chad Standifer representing PDC Staff, and Tabatha Blacksmith, PDC
24 Compliance Coordinator. Notice was provided to the Respondent and he appeared on his own
25 behalf. The proceeding was open to the public as limited by Governor's Proclamation 20-25 *et*
26 *seq.* and recorded.

8 **I. FINDINGS OF FACT**

9 The matter involves Respondent Richard De Gloria, City Council Member for the City

10 of Burlington. Respondent is alleged to have violated RCW 42.17A.700 for failure to timely file

11 a Personal Financial Affairs Statement (F-1 Report) with the Public Disclosure Commission no

12 later than April 15, 2022, disclosing financial information for the calendar year 2021.

13

- 14 1. In March and April of 2022, PDC staff sent email reminders to all elected and
- 15 appointed officials regarding their missing F-1 reports for calendar year 2021.
- 16
- 17 2. On May 11, 2022, PDC staff emailed the Respondent a warning notice regarding
- 18 the missing F-1 report.
- 19
- 20 3. On August 11, 2022, PDC Staff served the Respondent by email and mail with a
- 21 hearing notice for an August 25, 2022, Enforcement Hearing, along with
- 22 instructions on how to participate in the hearing remotely, before the full Public
- 23 Disclosure Commission concerning his failure to file the F-1 report.
- 24
- 25 4. As of the date of the hearing the Respondent has not filed the missing F-1 report
- 26

1 covering calendar year 2021 that was due no later than April 15, 2022.

2
3 5. The past due F-1 Report for 2020, has not been filed as of the date of this hearing.

5 6. There is one prior case for violation of RCW 42.17A.700:

- 8 • PDC Case 94185. At a July 15, 2021 Brief Enforcement Hearing,
9 Respondent was found in violation of RCW 42.17A.700 for failing
10 to file an F-1 report for calendar year 2020, which was due not
11 later than April 15, 2021. A total civil penalty of \$250 was
12 assessed in accordance with the penalty schedule adopted by the
13 Commission that was in effect at that time. As of August 25,
14 2022, the Respondent has not filed the required F-1 report but has
15 paid the civil penalty.

17 **II. CONCLUSIONS OF LAW**

18 1. The Commission has jurisdiction over this proceeding pursuant to Chapter
19 42.17A. RCW, the State campaign finance and disclosure law; Chapter 34.05
20 RCW, the Administrative Procedure Act; and Title 390 WAC.

21
22 2. Pursuant to RCW 42.17A.700, an elected or appointed official who held office
23 in 2021 was required to file an F-1 Report, disclosing financial information for
24 calendar year 2021 no later than April 15, 2022.



 - a. The missing F-1 reports for calendar years 2020 and 2021, are filed within 30 days of the date of this Final Order.
 - b. The Respondent remains in full compliance with all PDC reporting requirements and is not found to have committed any further violations of Chapter 42.17A RCW or Title 390 WAC within four years of the date of this Final Order. The suspended penalty shall not be assessed based solely upon any remediable violation, minor violation, or error classified by the Commission as appropriate to address by a technical correction.
2. If the Respondent fails to meet the conditions in Section III(1) of this order within 30 days of the date of this order, the suspended portion of the penalty for calendar year 2021 shall immediately become due and the matter may be sent to collection or brought to Superior Court as allowed by law without further action by the Commission.
