1. The FB page header was changed on October 3, 2022. A green check-mark graphic is used in the header. It is alleged the check-mark may have been included to solicit support for the levy, please explain the districts intent by including the graphic? The check mark was used as a generic voting symbol in providing information about the levy measure to encourage people to vote as it is a universal symbol for voting. A check mark itself does not imply a yes or a no vote and it was not intended to solicit support for the levy. The green color is one of our district's official brand colors, as shown in our brand guidelines (attached).

2. In the past year, has the Monroe School District included a check-mark graphic on other publications or FB posts? If yes, please provide examples of how the graphic has been used in 2022.

Yes, we have used check marks on graphics in 2022, see attached.

3. How about for prior levy or bond elections, has the check-mark graphic been used on publications or FB posts? If yes, please provide some examples of these earlier publications.
