In answer to your questions about my advertising in the LCN, I did purchase advertising - see attached invoices. I received the advertising - see attached - copies of the advertising that was run in the LCN.

I was interviewed by a reporter for the LCN. The reporter was Lanette Hoffman. She asked me if she could interview me and get a statement or two from me regarding my opinions and goals for the upcoming election. I answered her questions as best I could. It was my understanding that she was preparing an editorial about the upcoming election candidates in Lewis County addressing the choices people had available to them. I was not asked to give a prepared statement for publication. I was interviewed and answered the questions to the best of my ability based on my current knowledge. I did not notice the use of 1st person when the article came out. It did not seem out of the ordinary. I felt it was up to the writer's digression to choose the wording that she felt was appropriate.

I certainly did not consider that interview to be an in-kind donation to my campaign. I do not know if the article was of a benefit to my campaign or not. I do hope the voters benefitted from the interview in making their choices by having more information about me and the other candidates.

To answer your questions:

Yes, I did place three identical adds in LCN and yes, they were put into print at the appropriate dates I requested.

Those three adds were print outs of my flier that I used to hand out at parades and my door-to-door campaigning. (see attached)

I was contacted by 2 people about being interviewed. Gina and Ms. Hoffman. I had a few phone conversations with Ms. Hoffman where she asked me questions to put in the editorial that she was writing.

I did not feel it was an interview. Those conversations were very informal.

Gina contacted me first asking if I would be able to have a conversation with Ms. Hoffman about doing an editorial about the upcoming election candidates. I do not remember specific dates.

My understanding about the article was she wanted to help the voters get to know the candidates to better help them make informed decisions about the people they vote in to help run the offices in Lewis County.

This interview was in no way meant to come across as an advertisement and I have no control over Ms. Hoffman in regards to who she interviews nor what she writes.
I do hope this has clarified things regarding the complaint.
