In accordance with RCW 42.17A.110 and RCW 42.17A.755, the Public Disclosure Commission (PDC) will consider a report from staff concerning the status and possible resolution of this matter concerning complaints filed by Michael Christophersen and Tallman Trask alleging that the Bob Ferguson for Governor campaign violated RCW 42.17A.235 and .240 by failing to file the required contributor information for contributions transferred as lump sum amounts from surplus funds remaining after the conclusion of the 2016 and 2020 campaigns of Bob Ferguson for Attorney General. The Commission may consider accepting a Stipulation if presented by the parties. See [WAC 390-37-090](http://www.wa.gov/wac/390-37-090).

If you so desire, you may submit written material no later than 4:00 p.m. on Monday, October 23, 2023 for review by Commission members.
