Public Disclosure Commission Statement of Understanding Stanley Holland: PDC Case 137968

I, Stanley Holland, hereby acknowledge that I violated RCW 42.17A.710 (Stanley Holland)

and RCW 42.17A.205 by failing to: 1) timely and accurately report income, real estate, debts and a business association on *Personal Financial Affairs Statements* (F-1 reports) filed with the Public Disclosure Commission (PDC) covering calendar years 2019 and 2020, 1/1/2021 – 11/30/2021, and 5/26/2022 – 5/25/2023; and 2) timely file a *Candidate Registration* (C-1 report) with the PDC within two weeks of becoming a 2023 candidate. The C-1 report was due on or before June 2, 2023.

I would like to avoid the time and expense resulting from a Brief Adjudicative Proceeding (Brief Enforcement Hearing). Therefore, in lieu of a hearing, I acknowledge that I violated Washington law as described above and agree to enter into this Statement of Understanding (SOU) to resolve this case with the PDC. As part of the SOU, I amended my F-1 reports to include the missing disclosures between June 7, 2023 and August 18, 2023 and filed the missing C-1 report on August 8, 2023. Further, in accordance with the Penalty Schedule set forth in WAC 390-37-143, I agree to pay a \$250 civil penalty for violating RCW 42.17A.205 and RCW 42.17A.710.

I understand that I must return the signed SOU and \$250 in civil penalties so that they are received by the PDC no later than <u>August 24, 2023</u>.

By signing this SOU, I acknowledge that I violated RCW 42.17A.710 and .205 and waive my right to a hearing in this matter. I further understand that, by disclosing the missing information on my F-1 reports, filing my C-1 report, signing this SOU, and paying the \$250 civil penalty, PDC Case Number 137968 is resolved.
