<b>Complaint Description</b>
<p><a href="#">Glen Morgan</a> reported via the portal (Sun, 10 Sep 2023 at 8:44 PM)</p> <p>To whom it may concern,</p> <p>It has come to my attention that the Island County Democrats PAC has, consistent with past shady and illegal behavior, continued to violate Washington State's campaign finance laws (<b>RCW 42.17A</b>) in 2023, and for every year they have been "active" attempting to influence elections. The details are as follows:</p> <p><b>1) Total concealment of source of funds (Violation of RCW 42.17A.235, RCW 42.17A.240) Probable anonymous source of funds (Violation of RCW 42.17A.220(4)) Theft of funds for personal or illegal purposes (Violation of RCW 42.17A.445)</b></p> <p>Again, as I'm unfortunately forced to revisit some of the more egregious lawbreakers in the state when it comes to deceptive campaign finance violations, one of the groups that has been consistently addicted to lawbreaking is the Island County Democrats. In fact, they even attempted to dissolve a few years ago to avoid compliance with the law back then (I'll review their colorful lawbreaking history later in this complaint). <b>Despite getting caught multiple times in the past and despite past enforcement actions against this crew, they obviously just can't help themselves, and lawbreaking is such an important and defining part of their culture</b> they just can't seem to resist the temptation to break the law again. I'm not sure anyone associated with this organization in the last ten years has any concept of what life could be like without endlessly breaking the law.</p> <p>I've combined the three potential legal violations exposed by this first allegation into one explanation because, from the outside, <b>there is actually no way to untangle the legal mess this organization has created with their fraudulent financial filings. We can only attempt to translate and extrapolate the truth</b> from the very problematic, late, and clearly fraudulent claims made by the documents filed with the Public Disclosure Commission by this gang, and <b>all we really know is that the truth is concealed, the information presented is false, and nothing adds up.</b> While this may be consistent with the pattern of behavior <b>this crew has displayed for almost 10 years now while mocking the PDC and Washington State's campaign finance laws</b>, that doesn't mean that the public must accept the dishonesty or illegal behavior frequently exhibited by their actions here.</p> <p><b><u>The Mystery \$6,352.03. Who gave it to this crew? Where did it come from?</u></b></p> <p>I'll start with some of the more egregiously obvious violations under this category of lawbreaking. Sometime between December 31, 2022, and January 1, 2023 a reported <b>total of \$6,352.03 just magically appeared out of nowhere with no explanation</b> or clarification by this crew and was reportedly in their bank account. It is possible this is a true number, which means that either this crew accepted a large amount of anonymous contributions (for which, \$6,052.03 must be forfeit back to the state, consistent with <b>RCW 42.17A.220(4)</b>), or they just concealed the true source of this mystery cash stash, and they need to report the truth now, late as it may be (<b>Violation of RCW 42.17A.235 and RCW 42.17A.240</b>). Regardless of how much the PDC sanctions this crew, they will just laugh and continue to break the law.</p> <p>PDC staff can easily validate this fact for themselves by looking first at the last C4 (expenditure report) filed in 2022. For the record, this report was filed over 90 days late (See <b>PDC C4 Tracking # 110139502, attached for staff reference</b>). If you look at Line18, on this C4 report, you will see a negative balance of \$925.59. <b>By itself, a negative number on this line in a C4 report is an indication of a fraudulent report because as the PDC</b></p>

**so clearly indicates in writing (right below the line itself on the report), this should match the bank balance for this PAC. It does not.** However, it gets worse, as it always does when you look closer at the gang that runs this shady PAC. The very first C4 (expenditure report) filed by this crew for 2023 starts out with a miracle mystery cash balance of \$5,427.03 in the amended report filed 5 months late, of course, it was amending a 4 month late report, but who's keeping track? Nobody who works with the Island County Democrats, it appears). (See **PDC C4 Report # 110149676, attached for staff reference**). **The total difference in mystery cash exposed by just these two reports, assuming there is some attachment to reality by anything this crew reports to the PDC, they want the public to believe that suddenly a negative balance of \$925.59 became \$5,427.03 overnight, and they provide no explanation for how this \$6,352.03 appeared in their bank account.**

The more you look the worse it gets.

### **The mystery of the missing \$7,712.81. Who stole it?**

I'll direct PDC staff to the last C4 (expenditure report) filed by this crew of lawbreakers in 2021, for another example (See **PDC C4 Report #110069978, attached for staff reference**). Staff will notice that this shady crew of serial lawbreakers claimed they had \$7,712.81 in the bank. A nice sum to start the 2022 campaign season. However, when staff looks at the first C4 (expenditure report) filed for 2022, in theory starting the very next day – this money has vanished (**See PDC C4 Report #110107182, attached for staff reference**). Please note this report was filed over 6 months late. Where did the missing \$7,712.81 go? Who stole it? Was it wasted at the local casino? Did they attempt to conceal these funds and transfer them to Clyde Shavers secret off-the-books cash stash? Does anyone even know? Certainly the public has no way of knowing what happened here. It seems likely these funds were misused for personal illegal purposes, which would make it a **clear violation of RCW 42.17A.445**.

Just these two examples above indicate a minimum problem of over \$14,000 with little explanation as to what the heck is happening here? It is obvious that no documents filed by this crew are honest or accurate. As I've mentioned before in other cases where such dishonesty dominates the culture and behavior of a group like this – it seems likely that the PDC can save itself a lot of time and drama (particularly listening to the fake stories this group sends to the PDC), by **just getting simple subpoenas of the bank records (See RCW 42.17A.160) for this group and then working forward from that point. Whatever money was stolen or illegally added to this cash stash** - you may not know all the details, but at least you can start with how much it really was and when it was available or disappeared. Obviously, a lot of documents need to be filed by this group to report the truth they have hidden from the public so far.

### **2) Illegally concealing the truth from the voters by filing reports substantially late, as usual (Violation of RCW 42.17A.235, .240)**

This PAC also has frequently filed reports late. It is just habitual with this crew, and consistent with the culture over the past 10 years with this crew of lawbreakers. However, it is hard to really figure out what is happening most of the time due to the extreme late reporting (and inaccurate reporting as indicated above). **Due to the C4 reports indicating odd balances that are obviously fake or dishonest** (negative numbers or missing funds or surprise secret stash cash piles – see Allegation #1 above), the attached partial list of late reports is just for PDC staff reference based on an initial assessment of the problems this PAC has with accuracy, truth, honesty, or even marginal levels of compliance. Concealing the truth about the expenditures this PAC has made over the years is a real habitual problem.

The first spreadsheet I've attached, as always has links in the far right column to the original late report. I've highlighted the egregiously late reports in red. The problematically late reports in orange (14-5 days) and the

sloppily late reports (4-1 day) in yellow. This should provide the respondent the proper focus in explaining the apparent late reporting and is intended as a reference sheet for them to use and perhaps assist them as they sort out the missing funds and where they went. Plus they can narrow their focus then on the stories they plan to tell about **the cash stash that mysteriously appeared as well**. Please note most of these are not amended reports. Some of the small dollar reports are C4s still showing inaccurate balances on Line 18. Again, for PDC staff and the lawbreakers convenience, I have attached this file in both Excel and PDF formats.

The second spreadsheet is different than what I've provided to the PDC recently, but I've highlighted the particularly troubling late reports, which I believe on their own justify this allegation and requiring the respondent to clarify exactly what the heck is going on here. The yellow highlights in this spreadsheet are the reports, which on their own would justify filing a complaint about the egregious nature of the lawbreaking at this PAC.

Again, I **can't possibly see how to sort out the truth with this lawbreaking crew without filing formal subpoenas on their bank records (See RCW 42.17A.160)**. This is just a classic example where subpoenas will save lots of staff time, speculation, and drama so that staff can truly quantify the magnitude of the lawbreaking with this crew.

### **The Island County Democrats – A sad culture of corruption and a decade of lawbreaking**

The Island County Democrats are clearly **addicted to breaking the law** – particularly any law that involves compliance with Washington State's campaign finance laws.

I first caught their egregious lawbreaking back in 2017 (See **PDC Enforcement Case #21332** – complaint and response attached for staff reference). I had documented years of late reports, and this crew readily admitted my complaint was accurate and had merit. Rather than actually correct their lawbreaking, this committee at the time took the same action as a handful of other shady, illegal PACs at the time, and they attempted to illegally "dissolve" and then fraudulently convey their cash in an effort to avoid complying with Washington State Law (**See PDC Enforcement Case #28283**). This led to a Citizen Action Notice case filed by me on behalf of the state of Washington (since neither the PDC nor the AG wanted to enforce the law in this case) against this illegal crew of lawbreaking folk (See copy of attached complaint – **Thurston County Superior Court #17-2-04836-34**)

The fraudulent conveyance effort was made by these guys when they tried to dump their cash on their attorneys and the Washington State Democratic Party (See **"final" C4 filed in late 2017 – PDC C4 Report # 100798573, attached for the record**). At the same time, they pretended they no longer existed (**see letter dated November 3, 2017 from the attorney for the Island County Democrats**). However, Thurston County Superior Court Judge Lanese ruled against this tactic by the Island County Democrats on February 6, 2018, and this was consistent with a similar letter sent by PDC Executive Director Peter Lavallo to other PACs at that time who were attempting this tactic (see attached). **After this, the law firm quickly dumped the Island County Democrats as a client** (see letter attached).

**It is clear from past behavior, this organization will commit any crime, lie about everything and continue to do this moving forward if they believe they can get away with it.** No wonder Clyde Shavers felt so comfortable moving into this area and coordinating with them. So far, the PDC has been willing to let them break the law for many years. It is not clear if anyone in this organization has any interest in ever following the law in the future.

However, even if lawbreaking is an addiction with the Island County Democrats, I still believe in possible redemption for anyone. Even addictions to lawbreaking can be broken. There is an opportunity to turn over a new leaf, if they desire to do so.

Good luck trying to sort this crew out. Hopefully they don't try to dissolve themselves again to avoid compliance once again.





The purpose of this letter is to inform you about some recent developments pertinent to this case.

The Island County Democratic Committee PAC does not expect to be receiving contributions or making expenditures in support of, or opposition to, any candidate or ballot measure. Accordingly, it has complied with the procedures provided by the PDC to wind down operations and, as of today, the Island County Democratic Committee PAC no longer exists as a political committee. *See* RCW 42.17A.010(37).


Because the Island County Democratic Committee PAC has disbanded, it will not be filing an answer in this matter. We therefore suggest that you advise your client to promptly seek a voluntary dismissal of any and all claims he has against the Committee.

We are aware you have incurred attorney fees to date and that the prevailing party in actions brought under the Fair Campaign Practices Act ("FCPA") is entitled to an award of attorney fees. However, a "fee award must be reasonable in relation to the results obtained." *Ethridge v. Hwang*, 105 Wn. App. 447, 20 P.3d 958 (2001) (quotation marks omitted).

Knowingly incurring additional fees by pursuing further litigation against a now-defunct entity is clearly not "reasonable," for the purposes of a fee award. We therefore reiterate our recommendation that your client seek dismissal of the case as soon as possible.

# File a Formal Complaint - Glen Morgan

To Whom it May Concern --

It has come to my attention that the Island County Democratic Central Committee, as well as current & past officers Scott Chaplin, Janet St. Clair, Jerry Hill, Merri Huffine, Angie Homola, Steve DeHaven, Arthur Huffine, Brea Wetzel, Melody Risner, Gary McIntyre, Carolyn Tamler, and Sue Tingstad have habitually and willfully committed frequent and multiple violations of **RCW 42.17A**.

Additionally, I have reason to believe that other violations of this chapter have occurred beyond what I have identified below.

*By way of this complaint, I am alleging that the committee officers listed above also violated RCW 42.17A in the ways outlined in **PDC Complaint #21332**.*

## **1) Illegal dissolution of political committee. (Violation of RCW 42.17A.235(8))**

State law prohibits political committees from dissolving until they have discharged all debts & obligations and ceased all activity & functions.

The Island County Democratic Central Committee was unable to dissolve as it was legally obligated to file a response in a court case where they were a named respondent. As such, their dissolution is illegal and invalid.

Despite this requirement in state law, the officers of the Island County Democratic Central Committee chose to dissolve their committee on November 3, 2017 after being sued by the State of Washington for habitual, frequent, and serious violations of **RCW 42.17A**. *See **Thurston Co. Case No. 17-2-04836-36***.

The charges levied against the committee were serious, and – by the committee’s own admission in its response to the PDC– it was largely guilty of the violations initially identified in the initial complaint.

Yet, rather than face the consequences of their actions and pay a penalty for violating state law as other committees have done, **the Island County Democratic Central Committee opted to engage in a fraudulent conveyance scheme**. On the same day they dissolved their committee, they transferred the \$10,635 of remaining committee funds to their law firm (\$5635.39) and to the Washington State Democratic Central Committee (\$5000).

Pursuant to **Superior Court Civil Rule 12**, all defendants must provide an answer within 20 days of service. They were provided service of the amended complaint on 10/16/2017 and were required to submit an answer by 11/5/2017, but dissolved two days prior to that deadline.

The required answer and all other legal work on the case would constitute reportable activity (either as an expenditure/in-kind contribution/debt) that would have to be filed on form C4. As such, it is simply not possible for a political committee to dissolve itself during pending litigation.

Moreover, under **the absurdity doctrine**, U.S. courts have always interpreted statutes contrary to their plain meaning to avoid absurd results. If the PDC or the judicial system were to hold that committees could dissolve themselves mid litigation to escape liability, the result would be that political committees would simply dissolve in response to any substantive complaint. There would be no purpose in having any campaign finance laws as there would be no meaningful way to hold political committees accountable for their violations.

Please note that per **RCW 42.17A.904**, the provisions of **RCW 42.17A** are to be construed liberally to effectuate the policies and purposes of that statute.

## **2) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)**

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, the respondents have failed on numerous occasions to do this. *See final page.*

Furthermore, the political committee and its officers have failed to list how its remaining assets have been disposed of. This includes, but is not limited to, the money paid to its law firm.

It is unclear what work, if any, their law firm has performed for the committee beyond generating the attached form letter. \$5635.39 is an unreasonable price to pay for this work.

In addition, **PDC Report #100798573** was not filed correctly. Specifically, the following reported expenditure is not acceptable as a description for missing funds:

MATH CORRECTION 11/3/2017 \$78.86 OAK HARBOR WA 98277 MATH CORRECTION OF HISTORICAL DATA

If the balance of the bank account is off, the committee must identify the discrepancy and amend their reports to show accurate information.

## **3) State law requires that the committee treasurer preserve books of account, bills, receipts, and all other financial records of the campaign or political committee for not less than five calendar years following the year during which the transaction occurred. (Violation of RCW 42.17A.235 (6)).**

On information and belief, I believe that Island County Democratic Central Committee and its officers have failed to abide by this requirement.

Their actions in this matter to date indicate an unwillingness to behave within the confines of the law. It is highly likely that they have engaged in intentional spoliation of evidence. They should immediately be instructed to preserve all financial records in accordance with state law.

The PDC should investigate the near certainty that the Island County Democratic Central Committee and its officers committed the above violations maliciously, willfully, in concert with others all of which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.

Below is our response to the PDC complaint filed on 6/30/17.

Allegation One: Alleged violations of RCW 42.17A.235 for failure to timely report contributions and expenditures. Exhibits A and B were provided by Mr. Morgan.

This allegation is correct. We were late in filing reports.

Late filing was due to repeated difficulties in finding and keeping a Treasurer. There was not good continuity of Treasurer's duties and training.

Plan/Procedures for moving forward:

1. Treasurer keeps a list of our reporting deadlines, and ensures these dates are in the Treasurer's calendar/schedule.
2. Each month the Treasurer will email a copy of our latest ORCA/PDC filing to our Chair. This will confirm that filing has been timely and accurate. As oversight, the Chair will watch for and expect this email each month.
3. As part of the Treasurer's report given to officers each month, Treasurer will again confirm that PDC filing was timely and accurate. Written meeting minutes will reflect this.
4. Designated backup person will file PDC reports in event of the absence/illness of Treasurer. We will keep on file a list of our former Treasurers who have experience with ORCA/PDC filings. If current Treasurer is not available or able to function at reporting time, he/she or the Chair will contact the first person on the backup list.
5. In the event of resignation of a Treasurer, the Chair will immediately appoint one of the backups to serve as Treasurer. Chair will appoint a new permanent Treasurer in a timely manner, so there will be good continuity of duties/training.
6. We have purchased a laptop for exclusive use of the treasurer in filing PDC reports. This will build continuity between successive treasurers, and we will be able to more easily access our past PDC filings.

Allegation Two: Alleged violations of RCS 42.17A.240 and WAC 390-05-295 for failure to timely report debts and obligations. Exhibit C was provided by Mr. Morgan.

With regard to timeliness of reporting, this allegation is correct. We were late in filing reports. See our response to Allegation One above, including our plan for moving forward.

With regard to reporting debts, we did not understand that we had any debt to report.

Our PDC reporting is consistent with common understanding of the word 'debt' which includes the idea that payments would occur over time and/or beyond a 30 day timeframe. In watching the online training provided by PDC, their example of a debt was a contract with a consultant. That makes sense. However, when a vendor has been directly paid timely, within 30 days, we don't see an outstanding debt. Also, in practical terms we often have a reimbursement situation. Reimbursement to volunteers for an authorized purchase could sometimes take time due to delay in getting the receipt into the treasurer's hands; but we paid our volunteers timely after receiving request for reimbursement. The original vendor was paid by the volunteer immediately at time of purchase, so we see no debt there.

We need further guidance and training from PDC, as the RCW is not easily understood in practical terms. Please advise.

Allegation Three: Alleged violations of RCW 42.17A.235 and WAC 390-16-205 for failure to provide detailed breakdowns of expenditures. Exhibit D was provided by Mr. Morgan.

This allegation is correct, with regard to Exhibit D which provides 18 line items of concern. We took the opportunity to review all our C4 entries for 2016 and 2017 and found that in many cases not enough purchase/vendor details had been provided. Corrections to descriptions/details have now been made, and amended C4 forms have been filed.

Plan/Procedures for moving forward:

We will continue to provide detailed breakdowns of purchases and vendors going forward.

Allegation Four: Alleged violation of RCW 42.17A.205 for failure to list all committee officers, in particular Treasurer Brea Wetzel.

This allegation is correct.

Ms. Wetzel was the duly appointed and elected treasurer of the Island County Democratic Party as reflected in meeting minutes of 6/1/16 and our organization's Bylaws, Article IV- Officers, paragraph 4.2: "Officers: The officers of the Central Committee shall consist of a Chair, 1<sup>st</sup> Vice Chair, 2<sup>nd</sup> Vice Chair, Secretary, Treasurer, State Committeeman and State Committeewoman."

Unfortunately on our 2016 C1PC form Ms. Wetzel was listed as Treasurer only in section #5 (Treasurer's name & address), but her name did not appear in section #7 (Committee

officers) because we incorrectly thought she only needed to be listed once on the form. We corrected the error and submitted an amended C1PC form for 2016 on 7/21/17.

Plan/Procedures for moving forward:

We now understand the C1PC form, and will continue to show the Treasurer's name in both section #5 and #7.

Allegation Five: Alleged violation of RCW 42.17A.425 for allegedly allowing illegal unauthorized expenditures of funds by an individual not listed as an officer on C1PC form, in particular Treasurer Brea Wetzel.

This allegation is not correct. Brea Wetzel was authorized to sign checks for purchases authorized by Chair/Executive Board. She was our Treasurer, i.e. also an officer. No unauthorized purchases were made by Ms. Wetzel.

Per our response to Allegation Four above, we were in error by not listing Ms. Wetzel on the C1PC form section #7 as an officer, and this was corrected with the amended C1PC form filed on 7/21/17.

Plan/Procedures for moving forward:

We now understand the C1PC form, and will continue to show the Treasurer's name in both section #5 and #7.

We appreciate the opportunity to respond to this PDC complaint. It has been a learning experience, and we now have a plan for moving forward.

To Whom it May Concern --

It has come to my attention that the Island County Democratic Party has committed multiple violations of **RCW 42.17A** over a period of the last 3 years.

**1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)**

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt.

Unfortunately, the Island County Democratic Party has failed on numerous occasions to do this. (See **Exhibits A - "Illegally late deposits and contributions" and Exhibit B "Illegally late reported expenditures"**). Please note that many of these contribution and expenditure reports are significantly late. This is particularly egregious and substantially out of compliance. Please also note that **at least \$30,592.30 of contributions were reported egregiously late (130 different contributions), and over \$27,563.15 in expenditures (76 different expenditures) were also reported extremely late.**

I have good reason to believe there are other contributions and expenditures that have been made by the Committee that have still not been reported.

Please note, it is likely that the only way the PDC will be able to unravel the truth about what donations or expenditures were actually made from this political committee would be to subpoena the bank statements and verify the check registry as well (Please note, allegation #4 below would also need to be clarified based on check signatory and which officers had and do have signing authority at the bank during this timeframe).

**2) Failure to accurately, timely report debt. (Violation of RCW 42.17A.240 (8), see WAC 390-05-295)**

State law requires that the name and address of any person and the amount owed for any debt, obligation, note, unpaid loan, or other liability in the amount of more than two hundred fifty dollars or in the amount of more than fifty dollars that has been outstanding for over thirty days. Per **WAC 390-05-295**, this includes any oral or written order placed, debt or obligation to purchase goods or services or anything of value, or any offer to purchase advertising space, broadcast time or other advertising related product or service.

The Island County Democratic Party illegally failed to report the following debts: (See **Exhibit C - "Illegal failure to report debt"**)

**3) Failure to properly break down expenses. (Violation of RCW 42.17A.235, see WAC 390-16-205)**

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate's or committee's efforts shall be deemed expenditures by the candidate or committee. In accordance with **WAC 390-16-037**, such expenditures shall be reported by the candidate or committee as if made or incurred by the candidate or committee directly.

The Island County Democratic Party illegally failed to break down the following expenses. (See **Exhibit D - "Illegal failure to break down expenditures"**)

**4) Failure to list all committee officers. (Violation of RCW 42.17A.205 (2)(c), see WAC 390-05-245.**

The Island County Democratic Party failed to list its treasurer (Brea Wetzel) as a committee officer, which is required by **RCW 42.17A.205(2)(c)**.

The above individual should have been listed as a committee officer, because she, in conjunction with others, made, directed, or authorized expenditures, strategic or policy decisions on behalf of the committee.

**WAC 390-05-245** defines committee officer as: "...any person designated by the committee as an officer on the C-1 or C-1pc registration statement and any person who alone or in conjunction with other persons makes, directs, or authorizes contribution, expenditure, strategic or policy decisions on behalf of the committee" .

Please note that **RCW 42.17A.005 (35)** defines "person" as: "...an individual, partnership, joint venture, public or private corporation, association, federal, state, or local governmental entity or agency however constituted, candidate, committee, political committee, political party, executive committee thereof, or any other organization or group of persons, however organized."

**5) Illegal unauthorized expenditure of funds by an individual not listed as an officer on C-1PC form. (Violation of RCW 42.17A.425)**

State law requires that: "No expenditures may be made or incurred by any candidate or political committee unless authorized by the candidate or the person or persons named on the candidate's or committee's registration form..."

Despite making decisions for the Committee, Brea Wetzel was not listed on the C1PC. In her role as Treasurer, Wetzel doubtlessly made illegal expenditures on behalf of the committee.

The PDC should investigate the possibility that the Island County Democratic Party committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
