To whom it may concern,

It has come to my attention that the 49th Legislative District Democrats, once again, has violation Washington State's campaign finance laws (RCW 42.17A). The details of these violations are as follows:

1) Illegally exceeding contribution limits for mini-reporting. Failing to convert to full reporting political committee. Concealing this information from the public (Violation of RCW 42.17A.205, RCW 42.17A.235, RCW 42.17A.240, WAC 390-16-105, WAC 390-16-115, WAC 390-16-125)

On at least one occasion, this secretive dark money party PAC accepted a contribution far in excess of the contribution limit from one donor to a mini-reporting campaign (See WAC 390-16-105(1)(b)).

Specifically, this campaign received a \$2000 contribution from the Washington State Democrats on 8/23/2023 (See PDC Report # 110172389, attached for staff reference).

There is no evidence of this campaign refunding money to this PAC, nor is there any evidence of this campaign changing filing status from mini-reporting to full reporting (See WAC 390-16-125 for that process). Just to confirm, I have attached the C-1 which was updated a few months before they received this \$2,000 from the Washington State Democrats.

It appears likely that if this secretive PAC was willing to so openly violate the mini-reporting requirements laid out by the Washington State Campaign Finance laws, there are probably more laws they broke as well, but I'll share those details when I have them sorted out.

Please note, this is a crew with a history of violating Washington States campaign finance laws. See PDC Enforcement Case #26544, which I've attached for staff reference. This was based on a solid complaint I filed at the time in 2017, and the same players are involved. I was forced to file a Citizens Action Notice case against them at the time. This time, I hope the PDC considers more stringent penalties this time around. For now, this should be enough to investigate this crew of lawbreakers.

It has come to my attention that the 49th District Democrats have habitually and willfully committed frequent and multiple violations of **RCW 42.17A**.

1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, the 49th District Democrats has failed on numerous occasions to do this. (See Exhibits A - "Illegally late reported C3 and C4 reports")

2) Failure to accurately, timely report debt. (Violation of RCW 42.17A.240 (8), see WAC 390-05-295)

State law requires that the name and address of any person and the amount owed for any debt, obligation, note, unpaid loan, or other liability in the amount of more than two hundred fifty dollars or in the amount of more than fifty dollars that has been outstanding for over thirty days be reported on form C4. Per WAC **390-05-295**, this includes any oral or written order placed, debt or obligation to purchase goods or services or anything of value, or any offer to purchase advertising space, broadcast time or other advertising related product or service.

The 49th District Democrats illegally failed to report the following debts: (See Exhibit B - "Illegal failure to timely report debts").

3) Failure to properly break down, describe expenses. (Violation of RCW 42.17A.235, see WAC 390-16-205, WAC 390-16-037)

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate's or committee's efforts shall be deemed expenditures by the candidate or committee. In accordance with WAC 390-16-037 and WAC 390-16-205, such expenditures shall be reported by the candidate or committee directly. Additionally, in accordance with WAC 390-16-037, the exact purpose of the expenditure, the quantity of items printed, and the individual value of broadcast ads distributed on various media outlets must be disclosed on form C4.

The 49th District Democrats illegally failed to break down the following expenses. (See Exhibit C - "Illegal failure to break down expenditures")

The PDC should investigate the possibility that the 49th District Democrats committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
