| <b>Complaint Description</b>  |
| <p><u><a href="#">Conner Edwards</a></u><br/> reported via the portal<br/> (Fri, 20 Oct 2023 at 3:11 PM)</p> <p>This Tuesday (10/17/23), the 21-day pre-election C4 report was due (see note below), and candidates are obligated to file this report regardless of the threshold of activity on their campaign. All of the candidates on the attached list failed to meet this deadline. In fact, the above listed candidates failed to file a single C3 or C4 report over the 2023 campaign cycle, despite having selected the full reporting option.</p> <p>By any objective measure, it is unacceptable that the PDC would take no action to bring these filers into compliance now that ballots are out to the voters. The PDC has an obligation to provide transparency to the voters by enforcing filing requirements. I have tried many different times to get the PDC to take action against these types of non-compliant filers with no tangible results whatsoever. At one point, I believe the agency discussed the possibility of internally flagging non-filers in the PDC's system and proactively reaching out to them to bring them into compliance, but it appears this is not happening.</p> <p>Having exhausted all of my other options to pursue reform, the only remaining option available to me to compel the agency to take action here is to file PDC complaints against these noncompliant filers.</p> <p>By highlighting the agency's failure to meaningfully enforce current reporting deadlines, my hope is that the agency will look to improve its own enforcement procedures and help candidates and treasurers comply with the law.</p> <p><b>Notice to Respondents:</b></p> <p>I apologize to you for any inconvenience caused by this complaint; it is not my intention. No campaign treasurer or campaign/committee is perfect. Trying to comply with the myriad of requirements and deadlines the PDC enforces can be extremely difficult, even for those who have been doing this for years. The agency could adopt any number of strategies to help filers "get it right" when it comes to deadlines and other requirements. Some of these strategies might include: a) automated electronic filing reminders to a filer when they have missed a deadline, b) mandatory attendance in a PDC training course before a person is allowed to serve as treasurer, c) giving filers 48 hours to file 21- &amp; 7-day pre-election reports as opposed to the 24 hours we currently get, and d) improvements to the ORCA online campaign finance filing system to improve useability.</p> <p>If you are confused by the filing requirements that the agency enforces or are experiencing technical difficulties and/or usability issues with the ORCA system, please be sure to indicate this in your response to the PDC: your comments will provide valuable feedback for the agency.</p> <p><b>Complaint Notes:</b></p> |

- I originally attempted to submit this complaint via the agency's online portal on 10/19/23. I subsequently learned from agency staff that there was a SAW outage on 10/17/23, so any reports otherwise due on that day would now have been due on 10/18/23.
- Subsequent to my original attempted submission of this complaint on 10/19/23, I also learned that the agency has just sent out reminders to full filers who had not filed a 21-day C-4. The agency should be applauded for this effort. This is a step in the right direction, but it is not enough to merely send out reminders. Candidates who fail to file campaign finance reports by the applicable deadline must face monetary penalties, as is the practice with campaign finance authorities in neighboring states.
- A handful of these candidates may be running in political subdivisions fewer than two thousand registered voters as of the date of the most recent general election in the jurisdiction and, as such, be entitled to an exemption in RCW 42.17A.135 (1)(a). However, this exemption is subject to the exclusion contained in RCW 42.17A.135 (7) as further defined by rule in WAC 390-16-320. There should be a strong presumption that the exclusion contained in RCW 42.17A.135 (7) applies to these candidates (regardless of the size of the jurisdiction) as candidates in these jurisdictions have proactively filed statements of organization (C1s) and indicated full reporting which should be considered prima facie evidence that they are not entitled to the exemption.
- As of 10/20/23 at 3:06 PM, approximately a dozen candidates (out of 333) have filed at least some reports since I originally drafted it, so I have removed their names from the complaint.

#### **What impact does the alleged violation(s) have on the public?**

Because the candidates on the attached list have not filed C3 or C4 reports during the 2023 cycle, members of the public are unable to tell whether or not they have received contributions or made expenditures, significantly reducing transparency available to voters.

It is imperative that PDC staff reach out to these candidates immediately to bring them into compliance before the 2023 general election is concluded.
