In accordance with WAC 390-37-060(1)(d), PDC staff is issuing you a formal written warning concerning the requirement to timely and accurately file Cash Receipts Monetary Contributions (C-3) reports and Campaign Summary Receipts and Expenditures (C-4) reports. In the future, staff expects you to file timely and accurately as required. The Commission will consider this formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Subject: Complaint regarding Aisha Mayfield PDC Case 151256

Conner Edwards:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed against Aisha Mayfield, a 2023 candidate for Oak Harbor School District.

PDC staff reviewed the allegations; the applicable statutes, rules, and reporting requirements for a 2023 candidate under the Full Reporting option; the applicable Cash Receipts Monetary Contributions (C-3) reports and Summary Full Campaign Contributions and Expenditures (C-4) reports filed by Aisha Mayfield; and other relevant information, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- Aisha Mayfield filed a Candidate Registration on June 19, 2023, declaring candidacy for Oak Harbor School District Pos. 5, selecting the Full Reporting Option.
- For the 2023 election cycle, the 21-Day Pre-Primary Election C-4 report was required to be filed no later than July 11, 2023, the 7-Day Pre-Primary Election C-4 was required to be filed no later than July 25, 2023, and the Post Primary Election C-4 was required to be filed no later than Sept. 11, 2023.
- Mayfield did not file any C-3 or C-4 reports prior to the 2023 Primary Election.
- Mayfield did not advance to the 2023 General Election.
- On Nov. 4, 2024, Mayfield filed one C-4 report with the PDC. The report disclosed zero contribution and expenditure activity. Mini reporting, had it been selected, would have relieved the candidate of filing C-3 or C-4 reports.

In accordance with WAC 390-37-060(1)(d), PDC staff issued a formal written warning to Aisha Mayfield concerning the requirement to timely and accurately file Cash Receipts Monetary Contributions (C-3) reports and Summary Full Campaign Contribution and Expenditure (C-4) reports. In the future, should they declare candidacy again, staff expects Aisha Mayfield to file timely and accurately as required. The Commission will consider this formal written warning in deciding further Commission action if there are future violations of PDC laws and rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1), and WAC 390-37-060(1)(a).
