- ✓ **\$275 million** for the I-5 Bridge

- ✓ **E2SSB 5440:** Helps those struggling with severe mental health problems in the criminal justice system are being timely seen by doctors
- ✓ **ESHB 1311:** Protects consumers by requiring people claiming to have debt "solutions" are being transparent with their services and staying within the law
- ✓ **EHB 1797:** Ensures that qualified appraisers are allowed perform property valuations on all residential properties
- ✓ **EHB 1301:** Requires Department of Labor to look for ways to streamline professional licensure requirements so it's easier for people to connect to good-paying jobs.
- ✓ *We also amended the law regarding police pursuits, which will give more authority back to local law enforcement to enforce the law.*




