Subject: Complaint regarding TODD KINGSTON, PDC Complaint 143717

Conner Edwards:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed against TODD KINGSTON, a 2023 candidate seeking election to the office of PORT COMMISSIONER in the PORT OF SKAMANIA.

PDC staff reviewed the allegations; the applicable statutes, rules, and reporting requirements for a 2023 candidate under the Full Reporting option; the applicable Summary Full Campaign Contributions and Expenditures Reports (C-4 reports) filed by the Respondent; and other relevant information, to determine whether the record supports a finding of one or more violations. Based on staff's review, we found the following:

- TODD KINGSTON filed a Candidate Registration declaring her candidacy for PORT COMMISSIONER in the PORT OF SKAMANIA, selecting the Full Reporting Option.
- For the 2023 election cycle, the 21-Day Pre-General Election C-4 report was required to be filed no later than October 17, 2023, the 7-Day Pre-General Election C-4 was required to be filed no later than October 31, 2023, and the Post General Election C-4 was required to be filed no later than December 11, 2023.
- The Respondent changed to Mini Reporting on October 26, 2023.
- The Respondent filed expenditure reports for the periods they were not under Mini Reporting, but the reports were submitted late.
- The reports disclosed minimal contribution and expenditure activity that fell below the \$7,000 limit for a candidate choosing the Mini Reporting Option on their candidate registration. Mini reporting,

had it been selected from the outset of the campaign, would have relieved the candidate of filing any expenditure reports.

In accordance with WAC 390-37-060(1)(d), PDC staff issued a formal written warning to TODD KINGSTON concerning the requirement to timely and accurately file Summary Full Campaign Contribution and Expenditure reports (C-4 reports) in the future, should they declare candidacy again. The Commission will consider this formal written warning in deciding further Commission action if there are future violations of PDC laws and rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1), and WAC 390-37-060(1)(a).
