To whom it may concern,

I am reaching out to make a formal complaint against the candidate committee Faithful Friends of Claywell. Faithful Friends of Claywell received a \$700 donation on 5/9, but this donation was not deposited until 5/31, and not reported to the public until 6/28 (C-3 #110225005). This is in violation of rules regarding depositing and reporting contributions in a timely fashion. Three candidate loans were also made during this period (on 5/09, 5/11, 5/24) and were similarly unreported until 6/28.

Additionally, their C-4 (#110225006) for May was well over two weeks late, meaning that members of the public could not view campaign expenses, including advertising expenses such as their website. Their website Sponsor ID is also lacking full address/PO box information. This is in clear violation of the requirements regarding timely reporting and including an accurate Sponsorship ID on all political advertising.
