Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed July 2, 2024. The complaint alleged TaTeasha Davis may have violated RCW 42.17A for failure to accurately disclose expenditures on reports.

PDC staff reviewed the allegations and evidence you submitted; the applicable statutes, rules, and reporting requirements and other relevant information to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- The Respondent amended the report, disclosing the filing fee within one day of being notified.
- Fees associated with candidate declarations are a matter of public record.

Based on our findings, staff determined TaTeasha Davis made a minor or ministerial error, which did not materially impact the public interest but needed to be corrected for the report to be in full compliance with the requirements of the chapter.

Staff also determined that any violation regarding the timeliness of reporting was minor and has been cured.

After consideration of all of the circumstances, further proceedings would not serve the purposes of this chapter. Under WAC 390-37-060, the executive director, at any time prior to consideration by the Commission, may dismiss a complaint which on its face, or as shown by investigation, provides reason to believe that a violation has occurred, but also shows that the respondent is in substantial compliance with the relevant statutes or rules, or shows that formal enforcement action is not warranted. The executive director must report at each regular Commission meeting all complaints dismissed.

Based on this information, the matter is resolved as a technical correction pursuant to RCW
