The request from Conner Edwards for SiriusXM Media's records of political advertising was sent to an email address at SiriusXM not monitored by SiriusXM Media's legal or advertising teams. Thank you for bringing this matter to our attention.

SiriusXM Media no longer accepts political advertising for candidates for state, local or judicial office in the State of Washington. As far as SiriusXM Media has been able to determine, it accepted no such advertising during the 2024 election cycle. Please find attached copies of the relevant records requested.
