<p>rachel@standingforwashington.org reported via the portal <i>(Thu, 17 Oct 2024 at 3:31 AM)</i></p> <p>The law requires a C-4 report is filed twenty one days before the election, which is October 15. The Lets Say No Together has not filed a C-4 on Oct 15th, so as of today October 17th, there is no data available for their campaigns expenditures from 10/1/24 - 10/14/24. They filed a C-4 on 10/10/24 but it only covers the reporting period 9/1-9/30/24. This is illegal and a concern, as their campaign has spent significant funds in these first two weeks of October, including a mailer, yard signs and banners.</p>
What impact does the alleged violation(s) have on the public?
The Lets Say No Together campaign has spent significant funds over the last two weeks promoting their No campaign in Everett, including yard signs and banners and a mailer. Yet there is no expenditure information available for the first two weeks of October (up until the 14th as required by law) and it is now Oct 17th.

The evidence is available on the PDC website data for Lets Say No Together WA, there is a C-4 filed 10/10/24 with data reported through 9/30, but there is no C-4 filed for 10/15/24 that includes 10/1-10/14/24.

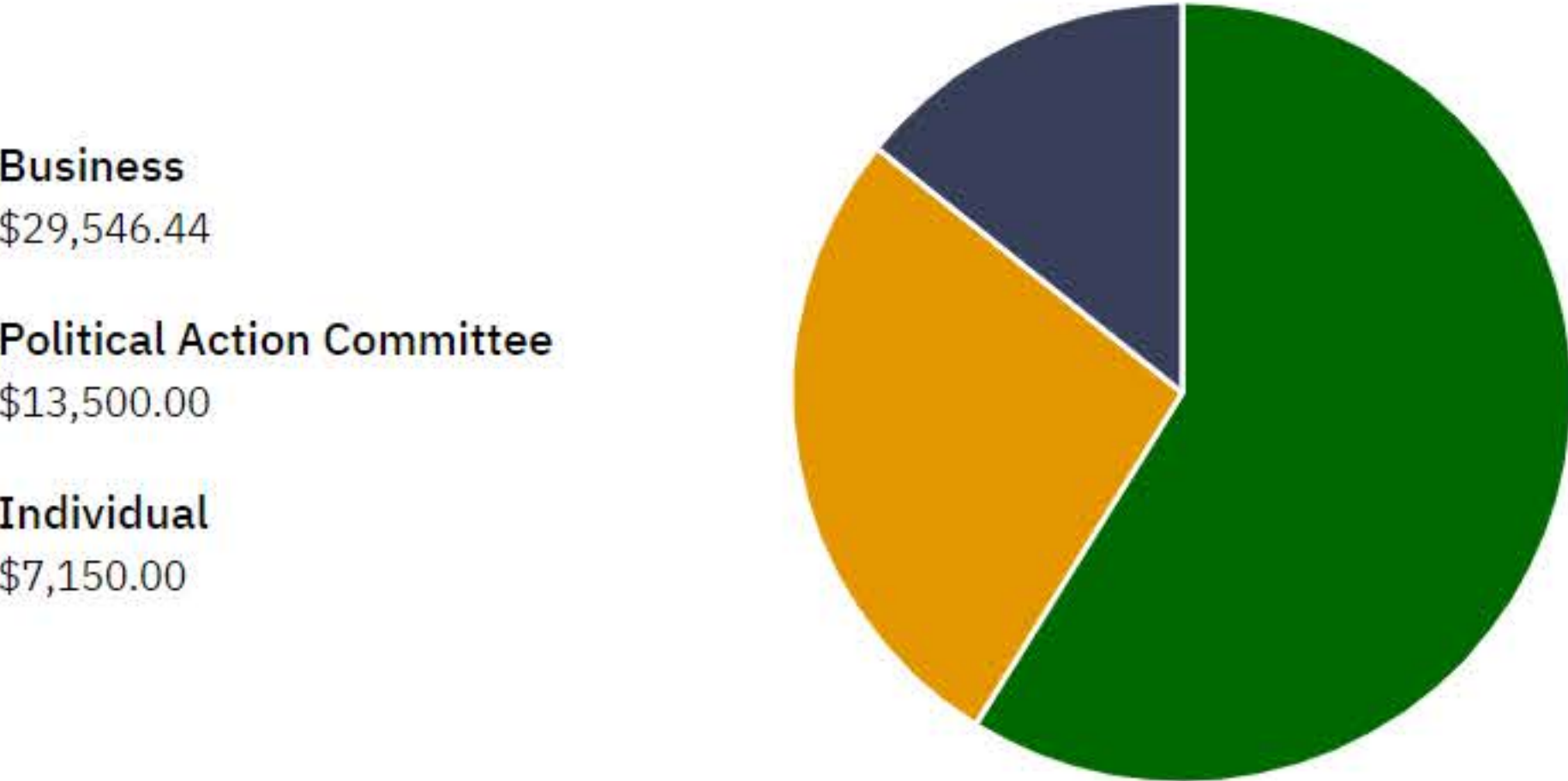

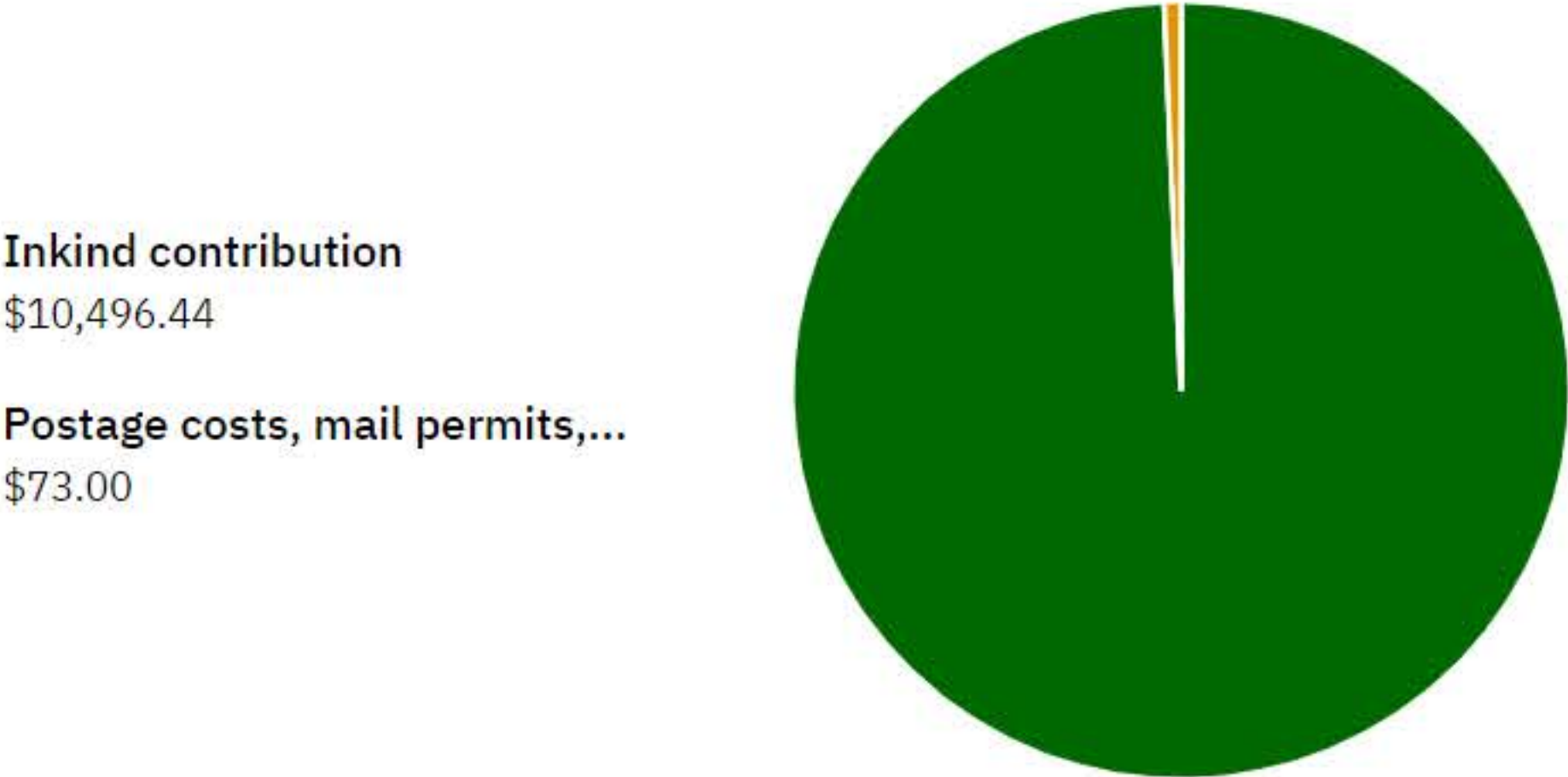

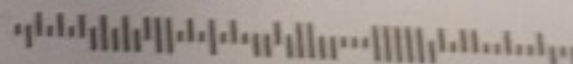
