Public Disclosure Commission Statement of Understanding Thurston County Democrats PDC Case 161581

I, Kait Toompas, in my capacity as Chair of the Thurston County Democrats (the Committee), hereby acknowledge that, during election year 2024, the Committee violated RCW 42.17A.235 and .240 by failing to timely and accurately file Summary Full Campaign Contribution and Expenditure reports (C-4 reports) and Cash Receipts Monetary Contributions reports (C-3 reports), disclosing contributions and expenditures.

The facts are as follows:

• The Committee was registered as a county bona fide party committee under the "Full Reporting" option during calendar year 2024.

JULY 2024

- The Committee filed the July 2024 C-4 report seven days late on August 19, 2024, disclosing \$50,655.07 in total contributions and \$29,124.03 in total expenditures.
- The July 2024 C-4 report was amended on December 8, 2024, to add missing expenditure descriptions.
- The Committee filed three C-3 reports seven days late on August 19, 2024, for deposits totaling \$48,212.26 made during the month of July from seven low-cost fundraisers.

AUGUST 2024

• The Committee filed the August 2024 C-4 report thirteen days late, disclosing \$150 in total contributions and \$6,729.31 in total expenditures.

The Committee would like to avoid the time and expense of a Brief Adjudicative Proceeding (Brief Enforcement Hearing). Therefore, in lieu of a hearing, the Committees acknowledges that it violated Washington state law as described above and agrees to enter into this *Statement of Understanding* (SOU) to resolve the above matter with the Public Disclosure Commission (PDC).

In accordance with the Penalty Schedule adopted by the Commission for Brief Enforcement Hearings set forth in WAC 390-37-143, the Committee agrees to pay a \$150 penalty for acknowledged violations of RCW 42.17A.235 and .240 by failing to timely and accurately file C-3 and C-4 reports, disclosing contributions and expenditures during calendar year 2024.

The Committee understands that, by signing this SOU, it acknowledges the violations of Chapter 42.17A RCW set forth above and waives its right to a hearing in this matter. The Committee further understands that signing this SOU and returning it to the PDC with the \$150 civil penalty will resolve this violation of RCW 42.17A.235 and .240 by failing to timely and accurately file C-3 and C-4 reports during calendar year 2024.
