Jordan, my name is Dawn Carr and I took over the position of the treasurer for VIS in May 2023. Our campaign was originally planned to be put to the ballot February 2026 in the special election, but the school district decided to change that and put it on the ballot for the 2024 General Election. Upon learning of their decision, I changed the date through the PDC but it was still coming up as February 2026 on the website, so I contacted the PDC to make sure that I had done it correctly. I had but the PDC had to have the tech team change it on the backend. I spoke with Ladelle, who helped with that. I can only assume that when it was changed over to reflect the 2024 general election it changed when we had filed the first C-4.

If you look at the C-3 reports starting June 18, 2022 and ending October 26, 2024 we have filed 43 C-3 reports. All of the C-4 reports throughout this campaign reflect the C-3 reports. Our first C-4 for this campaign was actually on June 18, 2022 not July 2024 which is what was stated in the complaint.

I apologize for the late response. I have been dealing with internet outages since the big storm and was out of town for the holidays.

In the initial email it stated to focus on the second complaint, so I thought that is what I needed to address. I am sorry for not responding about the other two issues.

So, on the first complaint about the report being filed late: I was waiting on contact information before I filed it. I wanted to put the correct deposit date and not put a wrong one just so I wasn't late. I knew the name but not the other information, I could have filed it as an anonymous donation but thought that would not be right considering I knew the name. I had to finally go to the school district to get the information which took a few days to get.

For the second complaint, with the ending balance and beginning balance not matching: The registration was filed in June 2022 with the vote being for the February 2026 special election. The school district decided to change it to the 2024 General Election, so I changed it through the

website. I did change it in June or July but it was not showing up on my end so that is when Lidelle had the IT team change it on the backend. If you look it does say August 2024 as being the registration date because that is when I changed it to the General 2024, when in fact it should be June 2022. I am sure that this is where the confusion is. All of the expenses and contributions have been filed properly for this election. The beginning balance for the first C-4 filed was \$11,357.18 and the beginning balance in August was \$44,479.18.

The third complaint happened before I took over the treasurer position, which was May 2023. When I try to click on the link it says : "Committee not found"

I did contact the previous treasurer and this was her response:

(a) I had no idea that I was supposed to report the number of items printed.

(b) Somewhere along the line, the PDC changed the software to specifically ask about sub-vendors, at which point I reported them. This was possibly an oversight on my part that I didn't realize it was a requirement before that time.

(c) Again, I had no idea that level of detail/specificity was required.

If I need to change anything on the reports I can, I just don't know how to change them for a previous election.
