Re: PDC Allegations Concerning Text Message Describing the Washington State Democrat Party's Platform Promoting The Chemical Castration Of Children In School.

Compliance Officer Hansen:

This letter responds to the PDC's two allegations regarding a text message sent by the Washington State Republican Party. In your email of November 19, 2024, you stated that the PDC alleged that the text message failed to include a sponsor ID, and identified that allegation as Allegation 2 in PDC Case Number 159267. In your email of November 20, 2024, you assigned PDC Case Number 162582 to your enforcement of a complaint brought by The Washington State Democrat Party, claiming that the contents of the text message are false and defamatory.

First, the text message plainly and unequivocally identifies the sponsor in the first words:

Hola, este es Matteo del Partido Republicano del Estado de Washington.

Your incomplete translation omits the first name "Matthew," but otherwise correctly reflects that the message is plainly identified as coming from the Washington State Republican Party.

Second, the Democrat Party, through its lawyers, complains that the text message is false and defamatory. It's not at all clear what part of the message the Democrat Party considers defamatory. The message is not only true but also accurately reflects both the Democrat Party's positions and the response of the vast majority of Americans to those reprehensible policy offerings.
