Glen Morgan reported via the portal (Wed, 16 Oct 2024 at 2:12 PM)

To whom it may concern,

It has come to my attention, once again, that the **Clover Park Citizens for Schools PAC** has violated Washington State's campaign finance laws (**RCW 42.17A**). The details are as follows:

1) Failure to report legally required details on expenditure reports (Violation of RCW 42.17A.235, RCW 42.17A.240, WAC 390-16-037)

This secretive PAC unfortunately, decided that concealing the legally required details on expenditures from the public was the best course of action, and this is unfortunate for both public transparency and basic lawful behavior. The specific violations are as follows:

**Example #1-3** – Three expenditures reported on January 15, 2024 are all legally deficient in the required details that PACs, like this one, must provide to the public as so clearly explained in **WAC 390-16-037**, **example B**. It can't be any clearer and everyone knows this. They still decided to break the law and conceal exactly how many door hangers were purchased from Vista Print for \$402.85, or how many yard signs were received from Express Signs for \$902.82, or how many posters were purchased from "Custom Poster Printing" for \$232.50. All of this was information concealed from a desperate public (See **PDC C4 Report # 110223886**, attached for staff reference).

2) Fake Vendor information presented to the public and false amounts reported to the PDC for expenditure (Violation of RCW 42.17A.235, RCW 42.17A.240, WAC 390-16-205)

This is not a super common violation, but it is worth pointing out for PDC staff reference, regardless. In one odd example, this committee appears to have misrepresented the actual expenditure amount they made.

**Example** – On August 13, 2024, this PAC reported that they sent \$617.40 to the "Public Disclosure Commission" for their settlement of previous lawbreaking activity, based on a previous complaint I filed against this crew a while ago. However, the true cost of this settlement was \$600, as evidenced by the Statement of understanding, signed by this organization at the time (See **attached SOU – PDC Enforcement Case #153195, attached for staff reference**). Where did the extra \$17.40 go? Why was this amount reported a false amount? (See **PDC C4 Report # 110243466, attached for staff reference**)

Of more concern than just inflated, incorrect costs are an entire category of fake vendors listed as expenses for this PAC. Let's review these examples:

I've attached a screen grab of a PDC summary report from the expenditures reported by this PAC and **includes about** \$2,804.90 given to a mysterious vendor called "Researching" using the same PO Box address as this PAC, but no description beyond this in most cases. This is not a real vendor, and doesn't appear to be a real address. Either way, there are sub vendors concealed here (See WAC 390-16-205) or this is just fake information provided to the PDC in the first place. Most of these can be found on the attached C4 (See PDC C4 Expenditure Report # 110223879, attached for staff reference)

I can't understand why this secretive dark money PAC would attempt to conceal the truth about these expenditures, particularly considering the fact that they spent thousands of dollars with their law firm and other experts, and they were forced to pay a \$600 fine, and they still are attempting to conceal the truth from the public.

It could be that \$600 was not a large enough fine to get their attention, but regardless of the fine size needed to get them to take Washington State's campaign finance laws seriously, we just have to keep trying to hold shady dark money PACs like

**this accountable.** Eventually, I'm sure we will get there, no matter how much this crew resists transparency and initially refuses to follow the law.

#### Dear Glen Morgan:

The Public Disclosure Commission (PDC) completed its review and assessment of the complaint you filed April 29, 2024. The complaint alleged that Clover Park Citizens for Schools may have violated RCW 42.17A.235 and RCW 42.17A.240 by failing to timely and accurately file Cash Receipts Monetary Contributions (C-3) reports and Summary Full Campaign Contributions and Expenditures (C-4) reports.

PDC staff reviewed the allegation(s); the applicable statutes, rules, and reporting requirements; the response(s) provided by Clover Park Citizens for Schools; the applicable PDC reports filed by Clover Park Citizens for Schools; and other relevant information, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- Clover Park Citizens for Schools (the Committee) is an Education Political Committee that has been registered with the PDC since at least 2008.
- The Committee's most recent registration, filed December 12, 2023, was listed as supporting a levy, bond or advisory vote in the February 2024 Special Election.
- Clover Park School District Proposition No. 1 was approved by voters in February 2024, receiving 59.57 percent of the vote.
- As noted in the complaint, the Committee filed numerous C-3 and C-4 reports in January 2024, reporting contributions and expenditures made between 2018 and 2024.
- In response, Juliana DeFilippis, attorney for the Committee, responded to the complaint noting the Committee's current (2023-2024) volunteers "realized the volunteer who used to oversee the PAC's reporting requirements was under the mistaken impression that the PAC was below the reporting threshold. After this realization, Clover Park hired a new accountant and legal counsel to ensure future compliance."

- The majority of C-3 reports filed with the PDC in January 2024 reported payroll deductions from Clover Park School District employees.
- DeFilippis continued, noting the PDC was informed of the Committee's actions to bring reporting into compliance before the complaint was filed and the Committee "provided a letter that explained the PAC's history and requested an alternate response to investigation or adjudication if a complaint should issue."
- The Committee timely filed two C-4 reports prior to the February 2024 Special Election. The first, filed January 23, 2024, listed \$18,106 in contributions during the campaign and \$1,431.23 in expenditures. The second, filed February 6, 2024, listed \$18,106 in contributions and \$7,685.31 in expenditures.
- While the Committee filed the pre-election reports timely, the amended reports filed in January 2024 included significantly different contribution and expenditure activity than was originally reported, which materially impacted the public interest.

Pursuant to WAC 390-37-060(1)(f), Clover Park Citizens for Schools completed a Statement of Understanding (SOU) and paid a \$600 civil penalty in accordance with WAC 390-37-143 (Brief Enforcement Penalty Schedule), acknowledging violations of RCW 42.17A.235 and RCW 42.17A.240. The \$600 penalty assessed resolves the allegations listed in the complaint.

Accordingly, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
