Complaint Description

Glen Morgan reported via the portal (Fri, 18 Oct 2024 at 11:36 AM)

To whom it may concern,

It has come to my attention that the **Cowlitz County Democratic Women PAC**, has violated Washington State's campaign finance laws (**RCW 42.17A**). The details are as follows:

1) Attempt to conceal major campaign contribution to political candidate from the public (Violation of RCW 42.17A.235, RCW 42.17A.240)

This is a full reporting committee (See 2024 C1 Registration Report, attached for staff convenience). However, they appear to not be fully reporting the truth and instead concealing the truth they are legally obligated to report to the PDC for an inquiring public to know. According to Cowlitz County Commissioner candidate Amy Norquist contribution report filed on September 9-2024, she received a max contribution of \$1,200 from the Cowlitz County Democratic Women PAC (See C3 Report # 110243507, attached for staff reference). Nowhere, and at no time did the Cowlitz County Democratic Women PAC report the truth, and instead they seem to be concealing it.

Based on their expenditure reports (or lack of expenditure reporting, to be more accurate), we can only presume that this is just the tip of the concealment operation organized and directed by this shady local dark money PAC. This attempt to conceal the truth, only accidentally discovered because of a cross-check contribution report analysis, and would have gone undiscovered were it not for this review and now this complaint. Hopefully, PDC staff can investigate and discover what else this crew is concealing from the public.

2) Failure to properly identify as a sponsored committee in an attempt to deceive the public and conceal the truth (Violation of RCW 42.17A.005(47)(b)(i), WAC 390-16-011A)

Unfortunately, the public deception doesn't end with just concealing secretive maximum contributions to local candidates from this shady dark money operation, but they have also concealed, for most of the campaign season in 2024, the clear and unambiguous fact that this was a sponsored committee with far more than 80% of their funds coming from one source. According to one of their rare C3 contribution reports filed on February 23, 2024, of the \$3,267 this PAC admits they have collected, \$3,020 of it has come from one person – a "Cross Ficke Deb" (assuming that is a real name and not a pseudonym) (See PDC C3 Report # 110202405, attached for staff reference)

Again, assuming this is a real person and a real name and it has been reported accurately – all of which are dangerous assumptions when it comes to this crew – they must rename their shady, secretive PAC in order to be compliant with the clear and unambiguous language in WAC 390-16-011A to "Cowlitz County Democratic Women, sponsored PAC by Cross Ficke Deb." If it turns out this was a fake name or a pseudonym used to conceal the true source of the cash, then the PDC may have to require a more intensive enforcement approach in this case.

3) Possible theft of funds. Missing Cash, and mystery cash appearing and disappearing without explanation from their bank accounts (Violation of RCW 42.17A.235, RCW 42.17A.240)

Once I discover one violation of our campaign finance laws by a shady dark money PAC like this, it seems inevitable that there will be more violations to uncover, and this organization is no exception, unfortunately. It just gets worse the closer I look. Here are the specific examples of this category of lawbreaking:

This secretive, sponsored dark money PAC claims they began the 2024 election year with \$6, 122.82 (**See illegally late filed C4 Report # 110202410**, **attached for staff reference**). While this was an illegally late filed report, at least they filed it. The problem becomes obvious, however, when you look at their final C4 expenditure report for 2023, where they claim they had \$5,883.40 in their bank account (**see line18 – on late C4 Report # 110197893**, **attached for staff reference**). This **discrepancy**

of \$239.42 raises some serious concerns. Where did this cash come from? Was it money from Chinese or Russian influence operations? Was it proceeds from an illegal meth distribution operation? Right now, the public can only speculate on the true source of this mystery cash stash. Unfortunately, it only gets worse from here.

This same Pac claims they began the 2022 election calendar year with \$4,603.01 in the bank (See timely filed C4 Report # 110073829, attached for staff reference). However, this same crew just a month earlier reported that they ended the 2021 election year with a bank balance of \$5,006.81 in the bank (see line 18 – timely filed C4 Report # 110069321, attached for staff reference). What happened to the missing \$403.80? Was it stolen? Was it an illegal bribe paid to elected officials? Was a concealed, secret contribution to a candidate? Is it fraud? Nobody knows the truth, and the public has a right to know.

This crew also claimed they began the 2021 election calendar year with \$4,529.05 in the bank (See illegally late filed C4 Report # 110014698, attached for staff reference). However, these same dark money guys claimed that they ended the 2020 election calendar year with \$4,483.41 in the bank on line 18 (See illegally late filed C4 Report # 110007219, attached for staff reference). Where did the missing \$45.64 go? According to the law, the C4 reports on line 18 must match the bank account balances, and this appears to not being done – someone is lying here.

These missing cash stashes and the true source of mystery funds must be revealed for the public to know what these guys are doing and who is truly funding them. Unfortunately, it continues to get worse from here.

4). Creation and use of fake donors to conceal true source of campaign cash (Violation of RCW 42.17A.235, RCW 42.17A.240)

Not content to just violate Washington State's campaign finance laws as explained above, this crew also has seen fit to conceal the true source of cash and contributions to their cash stash to influence elections by using fake contributor information.

For example, on August 12, 2023, this PAC claims they received \$1,857.10 from "Spaghetti Dinner" with no real name or address of where this cash came from. (See PDC Report # 110185696, attached for staff convenience). True information about the source of funds must be provided to the PDC for the public to know, otherwise it must be treated as anonymous contributions and subject to forfeit to the state of Washington under RCW 42.17A.220.

This dark money crew can't hide behind shady tactics, deceptive reporting, and efforts of election interference like this with their behavior which clearly threatens Democracy.
