This complaint that I am filing is that the Northshore School Board engaged in announcing a Special Meeting-Town Hall on Tuesday, October 15, 2024 in reference to a NO I2109 Capital gains Initiative, by providing only one side to the general public. I am filing a complaint against the Northshore School District School Board for violation pf RCW 42.17.555 (Public facilities may not be used to support or oppose a candidate or ballot proposition). The school board utilized the use of district facilities, a clear violation. In addition, the school district/board did NOT distribute an objective and fair presentation of the facts for the I2109 ballot measure but provided only one side - the NO on I2109 Capital Gains Initiative.

PTS's may use school facilities for meetings supporting or opposing a ballot measure to the extend that the facilities are made available on an equal access, nondiscriminatory basis, of which was NOT done. They clearly opposed a ballot measure I2109. 4 NO on I2109 signs were placed on and inside school grounds at the North Creek High School prior to the Special Meeting-Town Hall. And all of the signs were removed afterwards and video and photographs were obtained and are included here as exhibits. All of the literature on the table was all NO on I2109 literature. There was no YES on I2109 literature present for attendees. Photographs were obtained. All of the speakers that presented and spoke were all speaking for the NO on I2109. When asked if there were any speakers invited and present to speak on behalf of the Yes on I2109 the answer was no. There were three Northshore School Board members present: President Amy Cast, Sandy Hayes and Jacqueline McGourty. They were asked why they were there and they all three responded they were there to answer any questions. They did say when asked if they had not passed a Board resolution endorsing I2109. Others present that presented on the No I2109 ballot initiative were Calvin Jones who is the Outreach Director for Defend Washington, who also presented a slide presentation on the NO on I2109. Davina Duerr a member of the Democrat state House 1st Legislative District also spoke on NO on I2109. Shelley Kloba a Democrat House representative from the 1st District was present and she acted as the moderator. Kristina Brown, a lobbyist with Kingering.org was also a speaker at the event and spoke on being supportive of NO on I2109, lobbying for NO I2109. It should be noted that Brown as of this date has not filed her October 2024 Lobbying report to the PDC. The moderator Shelley Kloba opened up for questions on the NO for I2109. It appeared that there were only two individuals from the public present that asked questions and pushed back to the NO on I2109. There were no presenters on the YES for I2109. When asked if there were going to be any Yes on I2109 presenters-the response was no. Photos were taken of some of the attendees listed.

1. On 9/1/2024 at 7:09 p.m., Northshore School Board President Amy Cast sent an email to Superintendent Tolley stating that Representative Duerr had reached out to her to see if Northshore could help support a town hall at NCHS (North Creek High School) to discuss the capital gains initiative.

2. Tolley responded to Cast on 9/2/204 7:26 P.M. stating he would work with staff to determine if and when one maybe possible.

3. Cast responded back on 9/3/2024 at 7:41 A.M. with a date of 10/13/2024.

4. Cast responded on 9/10/2024 at 7:39 a.m. stating Rep. Duerr would like October 16, 2024 as the date.

5. Cast responded on 9/10/2024 at 8:15 a.m. stating they wanted to use the NCHS Commons at 6:00 p.m. Tuesday, October 15, 2024.

6. Vanessa Greek the facilities specialist at the Northshore School District responded on 9/10/2024 at 2:34 p.m. to the room request.

7. On 9/10/2024 at 11:10 a.m. President Amy Cast wrote to Davina Duerr stating the North Creek team is able to support the request for a public forum at North Creek on Tuesday, October 15 at 6. Cast in her email suggested putting up a sign or two outside to help community members find the Commons.

8. On 9/10/2024 at 2:57 p.m. Peggy King the Administrative Assistant to the Superintendent and the Board of Directors sent an email to Vanessa Greek with a note that read "I have just the Board request for a Town Hall Oct 15 @ 6:00 PM"

9. On 10/11/2024 at 8:20 a.m. President Amy Cast sent an email to Peggy King stating she Cast would be getting there early to help setup.

10. On 10/10/2024 President Amy Cast sent an email to Peggy King stating that three Board members would be attending the event, and that a microphone would be needed.

11. On 10/10/2024 President Amy Cast Sent an email to Davina Duerr with information about the event, including suggesting put up signage.

12. On 10/11/2024 at 4:23 p.m. Emily Bass from Shelly Kloba's office sent an email to Peggy King with instructions for chairs and tables needed and where to be placed, and information that one of the speakers had slides to show and needed a projector and screen.

13. On 10/10/2024 at 7:23 p.m. Emily Bass the Communications Director for Shelley Kolba sent an email on behalf of Shelley Kolba and Davina Duerr with instructions.
