<p>Glen Morgan reported via the portal (Fri, 18 Oct 2024 at 9:44 PM)</p> <p>To whom it may concern,</p> <p>It has come to my attention that the 20th Legislative District Democrats PAC, has, violated Washington State's campaign finance laws (RCW 42.17A). The details are as follows:</p> <p>1) Attempt to conceal true sub vendors from the public on expenditures (Violation of RCW 42.17A.235, RCW 42.17A.240, WAC 390-16-037, WAC 390-16-205)</p> <p>This secretive, shady, dark money PAC has violated Washington State's campaign finance laws despite the simplicity, clarity, and very obvious requirements explained in WAC 390-16-205 when they reported an in-kind expenditure from the Washington State Democrats for "Received 25 Yard Signs from State Party" valued at \$624.84 on 9/29 /2024. Despite the ease of complying with Washington State's campaign finance laws, this crew decided to clearly threaten Democracy by willfully failing to provide the sub-vendor information for an inquiring public to know the truth. Who printed the signs? Where are these secretive sub vendors located? Was it a foreign corporation located in China? Was it Russia? Who knows, and these guys aren't talking. As if these egregious violations were not enough, they also decided to conceal from the public which candidate (or candidates) these signs are supporting. Again, WAC 390-16-205 is so clear on this matter, yet they decided to break the law anyway. (See PDC C4 expenditure Report # 110252508, attached for staff reference).</p> <p>While this clear threat against Democracy, Freedom, and the very future of our state must be addressed, this violation should also be recognized as a serious problem and indication that this dark money Pac crew is heading in the wrong direction with this type of election interference and misinformation.</p> <p>Let me know if you need any more on this one.</p> <p>Best Regards,</p> <p>Glen Morgan</p>
