I'm writing to respond to an email you sent to Bud Sizemore re: complaint 170049 (Attached). Bud no longer works here, and your email was forwarded to staff.

The complaint points out that this

C4 <https://apollo.pdc.wa.gov/campaigns/ORCA/campaign/24304/report/110276377> was due October 10, 2024 and submitted late, March 17, 2025. We thought the last report due for the primary campaign was for the period July 30 - August 31, 2024 and we submitted that report September 5, 2024. A vendor associated with the primary campaign contacted us in March 2025 about a possible refund. Because we had closed the campaign and the bank account associated with it, I reached out to the PDC for guidance. At that time, PDC staff informed me I should have submitted a report for the period ending September 30, 2024 and I immediately submitted the report.

The complaint also points out that the \$5,500 indicated on the September 2024 report was not reported as a debt on the post primary C4 nor the 7-day pre-primary C4. We did not report that because we didn't receive the bill until August 29, 2024, and we paid it on September 11, 2024.
