This email is in response to the complaint filed by Conner Edwards, PDC Case Number 170194. The alleged violation is RCW 42.17A .235 & .240 for failure to timely and accurately disclose contributions & expenditures on reports.

All reports were filed in a timely manner however, the reports were filed under the year 2024 instead of 2025. I have embedded the email from the PDC below stating the report was filed by March 3 2025. We also filed our April report in a timely manner but it was also filed under the year 2024. I have embedded that email also below.

I contacted the PDC on April 7th asking them for clarification as I did not see donations and expenditures listed for the year 2025.

The response is below.

We have since corrected the year and moved all filings to the year 2025 per Scott Haley's direction. Thank you for your assistance in this matter. As for the in-kind donations- I have not received any in-kind donations as of yet. I contributed my own funds of \$682.54 to start my campaign. The PDC staff said we did not have to report those expenditures supported by candidate funds until we reached \$750.00 -but we have recorded those expenditures as of now.

Please let me know if there is anything else you need from us. We appreciate the quick response and guidance you have given us .

On December 24, 2024, you filed a C1 candidate registration for you as a candidate for mayor of the City of Monroe for the 2025 general election. This one was certified by a Secure Access Washington account under the email address [pcudaback@ymca-snoco.org](mailto:pcudaback@ymca-snoco.org). On February 8, 2025, we received another candidate registration for you. This one showed the election year as 2024, not 2025. The registration for year 2024 was certified with a SAW account under the email address [bhasart@slwsd.com](mailto:bhasart@slwsd.com). An ORCA campaign was created from the registration showing the election year as 2024. C3 and C4 reports have been filed using the registration for year 2024.

I think that your treasurer, Becky Hasart, doesn't see the registration for year 2025 under "committees I file for." With your permission, I could grant her access to that committee registration, so she'd see the 2024 and the 2025 registrations under "committees I file for." She could then create an ORCA campaign for year 2025 and report the financial activity for your campaign for year 2025. She could then amend the reports for year 2024 to show no contributions and no expenditures for a 2024 election. She could contact the PDC for assistance if she needs any help doing this.
