## Complaint Description

To whom it may concern,

It has come to my attention that State Senator T'wina Nobles from the 28<sup>th</sup> Legislative District has violated Washington State's campaign finance laws (**RCW 42.17A**) every year she has been involved in the political process. The details of this violation are as follows:

### **1) Successful attempt to conceal critical financial information from the public by deceiving the public with false Financial Public Disclosure Reports (Violation of RCW 42.17A.700)**

In this case, Senator Nobles exposed her own prolific violation of this statute by sharing a post **on her social media account, revealing that at least two different debts, one \$40,898.48 and the other one for \$61,814.39 was forgiven, presumably under some type of Federal student debt forgiveness loan and she was able to wipe these debts totaling over \$102,712.87 in late 2023.** While I am personally happy that Senator Nobles was able to convince someone else to wipe away her debt and these loans, unfortunately, she willfully decided to conceal this large debt from the public on every Financial Affairs form (F1) that she filed with the PDC going back before the 5 year statute of limitations.

I've attached the last 5 years of F1 reports that were falsified by this State Senator to conceal the truth from the public (attached for staff convenience).

This is critical information that remained concealed by this State Senator who was in a position of authority and influence in government during this time to influence public policy and advocate for public policy which would have the impact of benefiting her personally. She could do this, of course, and probably does so on a regular basis, but **in this example, she should still not file fraudulent documents and follow the law and reveal the truth so that the public knows or is at least aware of the potential conflict of interest and self-interest this high profile elected official would have to influence and legislate public policy.**

While I do frequently catch elected officials falsifying these documents, these are generally challenging violations to uncover and it is generally possible for elected officials like this one to conceal the truth and file fraudulent illegal forms for years in an effort to deceive the public and conceal the truth. In this case, this elected Senator had years to correct the record and self-report, **but she chose to violate the law every year and continue her illegal actions.** This is sad and unfortunate, but I believe the Public Disclosure Commission needs to take this seriously.

Obviously, if we fail to apply the law for open and flagrant violations like this and fail to impose penalties on a powerful state senator like this, then **we only encourage more fraudulent and illegal behavior with other candidates and incumbent politicians in the future**

For the record, this incumbent is currently running for office, so she has successfully concealed the truth from the public through multiple election cycles now and appears poised to succeed in concealing the truth moving forward. Additionally, I am concerned that if this politician is willing to so blatantly commit fraudulent behavior like this and flaunt it on her social media accounts, then I am concerned there is much more information concealed from the public, and PDC staff should address any additional concealed information in their correspondence with this incumbent politician.

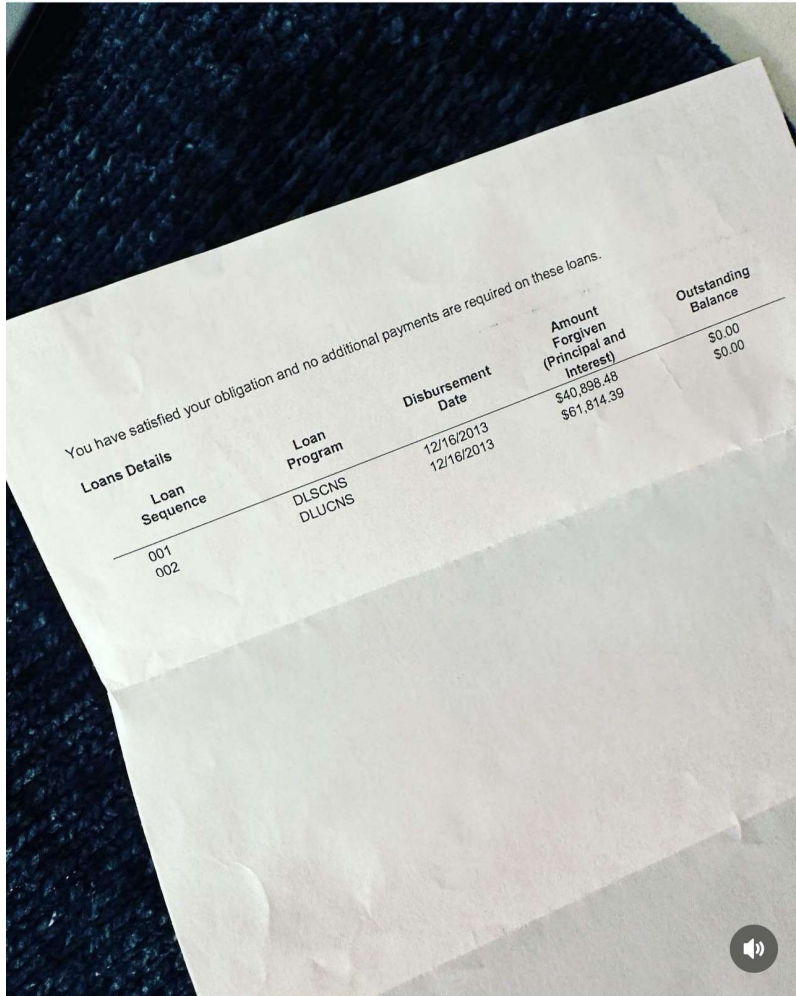
