Background

Washington State’s Campaign Finance Disclosure Law

One of the primary purposes of the public disclosure law is to provide citizens of this state, and especially voters, with the means for becoming informed about the financing of political campaigns.¹ The public disclosure law was enacted through voter approval of Initiative 276 in 1972.

State law requires candidates and committees that register under full reporting to submit regular reports of financial activity. Those reports are filed on schedules outlined on the PDC’s key reporting dates calendar.²

Violations

In May of 2025, the Thurston County Democrats held an auction as part of their Blue Gala event.

As part of this auction, numerous donors made in-kind donations of goods/services that would be bid on by attendees of the Blue Gala event, with proceeds to go to the Thurston County Democrats. Additionally, please note that this page does not contain a “paid for by” statement, in violation of RCW 42.17A.320.

While it is difficult to correspond the auction with the auction proceeds without the formal C3-AU form being filed, it appears that the proceeds of the auction were disclosed on this C4 report, see link: <https://apollo.pdc.wa.gov/public/registrations/campaign-finance-report/110289708> .

Furthermore, the PDC requires that auction proceeds be reported in the manner described below.

Auctions

Auctions, other than qualifying low-cost fundraisers, must be fully reported on an Auction Report (Attachment Au), with the total received noted on line 1d of the C-3.

The ORCA system makes reporting auctions very easy: After the auction is held, enter each auction item, contributor information for each item's donor and buyer, the item's fair market value and sales price. Based on this information, the software determines who contributed the auction's proceeds. (When a donated item sells for its fair market value or less, the amount the item sells for is contributed by the item's donor. When an item sells for more than its fair market value, the item's fair market value is a contribution from the item's donor and the excess is a contribution from the item's buyer.)

Preparation is the key to simplifying the reporting of auctions.

Pre-auction: Make a list of the donated items. You'll need a brief description of each item and its fair market value along with the donor's name, address, and occupation/employer information if the donor is an individual.

During the auction: Keep track of who buys each item and the winning bid amount. You'll need the bidder's name, address, and occupation/employer information if the bidder is an individual.

It appears that the Thurston County Democrats did not disclose the auction proceeds in this way. **Furthermore, the in-kind donation of the goods/services which were auctioned off appear to have never been disclosed.** See for instance that the \$1000 FMV "5 Night Stay at a Club Wyndham Resort of Your Choice" from Christine Garst was not disclosed as an in-kind.

Conclusion

I urge the PDC staff to take quick action and resolve the noncompliance identified in this complaint.

Notice to Respondent

I apologize to you for any inconvenience caused by this complaint. The chance that you will actually be fined for the violations identified above is extremely small because the agency is averse to doing the work necessary to bring cases to hearings. Most likely this case – and any future cases against you – will simply be dismissed by staff.

This complaint is one of over one thousand complaints that I have filed to highlight and ultimately fix the significant shortcomings associated with the agency responsible for administering our state's campaign finance laws.

What are these shortcomings?

Overcomplicated and outdated requirements that are difficult to understand and comply with. Failure to properly educate the regulated community about the tasks they must perform to remain in compliance with applicable requirements and avoid complaints. Failure of the agency to send regular reminders to

filers about pending deadlines. A failure to proactively enforce applicable requirements which enables the complaint system to become weaponized. Non-intuitive, non-user friendly, and buggy reporting software. Failure to meaningfully enforce core requirements. Failure to follow the best operating practices of other neighboring campaign finance agencies. An agency leadership structure that largely disregards stakeholder input and is slow to identify and resolve major agency deficiencies.

I believe that the best way to motivate the agency to address these problems is by filing a large number of complaints so that the agency's problems become impossible to ignore.

If you believe that the agency could have done something different to help you proactively avoid the issues identified in this complaint, I hope that you will consider including it in your response. The agency, and the public, can benefit from your perspective and feedback.
