Hello Tabitha,

I'm following up on your e-mail from May 8th on PDC case Number 171161.

Here what has happened with filing of PDC reports for PAPAC in 2025.

We used to file for Physician Anesthesia PAC (PAPAC) PHYSAP 121 since 2007, it's a continuing committee.

PAPAC doesn't have any CANDIDATES or ELECTIONS; it is just a continuing political committee.

For some reason we were unable to create a continuing campaign at the beginning of this year and were advised to create a New Committee for 2025 instead of creating new campaign – Physician Anesthesia PAC (PAPAC) CANDM-016.

However, while registering new committee we figured out that there wasn't an option on PDC website for NOT choosing candidates or elections.

We were trying to delete New Committee CANDM-016 and get back to old 2007 committee filing but we couldn't.

We contacted PDC team then and advised what we need to do to fix the issue.

Ashley Carlson, Disclosure Specialist from PDC was very helpful and connected with PDC IT team. They were able to merge the records and get filings back into 2007 Continuing Committee PHYSAP 121.

The final balance now is correct and matching our QB records.
