<b>What impact does the alleged violation(s) have on the public?</b>
<p>This is my third public disclosure complaint about council member Bruce White in the City of Milton as he campaigns for mayor. My first complaint was #164733 (a warning issued) and the second complaint was #172938 and it is pending.</p> <p>I cite RCW 42.17A.320 and RCW 55.</p> <p>His campaign sign does not have the sponsor ID or the website. He also put his campaign signs up on easements abutting private property without permission. In December 2024, he went door-to-door to ask for signatures to put his name on the primary for mayor of Milton and waive the filing fee. If they signed the petition, he began just putting signs in the yards. One neighbor informed me he did not give permission for a sign. To which, Mr. White disagreed and said you signed the petition.</p> <p>His webpage is suspect. In the campaign against me in 2020, he had a webpage that was parked at go daddy. This current webpage is suspension as well. No info and when you are on the page, it shows info at the top again at Go Daddy.</p> <p>His political signs in the yards do not include the sponsor ID or website. Does not show the words "Paid for and by" or give an address. I was given a campaign handout whereby he did add a sticker to comply on the document.</p>
