<b>Complaint Description</b>
<p><a href="#">Emily Tadlock</a> reported via the portal (Wed, 4 Jun 2025 at 2:45 PM)</p> <p>It has come to my attention that candidate Julie Hsieh appears to have violated Washington State's Campaign Finance laws (RCW 42.17A). Specifically, this case alleges a violation of RCW 42.17A.710 for failure to disclose business interests and accounts of spouse on a candidate Personal Financial Affairs Statement (F-1 report).</p> <p><b>Missing Candidate and Spouse Business Association (Yopey Yohey LLC)</b> Julie Hsieh failed to disclose business association with spouse, David Figatner, in Yohey Yohey LLC (Attachment 1, Candidate F-1 report). Julie Hsieh and David Figatner are listed as officers (Governors) in Yohey Yohey LLC (Attachment 2). This business association should be disclosed on her F-1 report under "Business Associations".</p> <p><b>Missing Spouse Assets (Fidelity):</b> Julie Hsieh's spouse, David Figatner, filed for a School Director position in 2023 (Attachment 3). Under "Assets," David disclosed 4 Fidelity Investments accounts (types: IRA, Retirement, Stocks and 401K) that amounted to a combined value of at least 1.4 million dollars (Attachment 3, marked). These 4 Fidelity accounts are not listed on Julie Hsieh's 2025 F-1 and three of those accounts are the type of accounts that generally don't go away in two years. It appears that Julie and David may have purchased a house after David's F-1 disclosures in 2023, which may explain where some or all of the funds from those 4 Fidelity accounts were used. However, it is essential that all assets—both for the candidate and their spouse—are fully and accurately disclosed.</p>
<b>What impact does the alleged violation(s) have on the public?</b>
Filing reports that disclose assets and business associations is more than a mere formality. When candidates fail to provide complete and accurate information, the public is harmed. Voters have a right to know about a candidate's income, assets, and business interests—that's why candidates are required to file an F-1 statement.
