One of the primary purposes of the public disclosure law is to provide citizens of this state, and especially voters, with the means for becoming informed about the financing of political campaigns.<sup>1</sup> The public disclosure law was enacted through voter approval of Initiative 276 in 1972.

State law requires candidates and committees that register under full reporting to submit regular reports of financial activity. Those reports are filed on schedules outlined on the PDC's key reporting dates calendar.<sup>2</sup>

**Violations**

I am filing a complaint because it appears that the entity Progress Alliance of Washington has failed to register as a political committee pursuant to RCW 42.17A.205 and failed to file C3 and C4 reports pursuant to RCW 42.17A.235, and .240.

PDC Interpretation 07-02 sets forth the "Primary Purpose Test" guidelines for which entities are required to register as political committee and file frequent reports of contributions and expenditures. There are two independent qualifying activities included in the definition of what constitutes a political committee: receiving contributions and making expenditures.

The registration requirement can be triggered by either of those activities. While the respondent may qualify under the contribution prong, I believe it certainly qualifies under the expenditure prong based on publicly available information.

## **Notice to Respondent**

I apologize to you for any inconvenience caused by this complaint. The chance that you will actually be fined for the violations identified above is extremely small because the agency is averse to doing the work necessary to bring cases to hearings. Most likely this case – and any future cases against you – will simply be dismissed by staff.

This complaint is one of over one thousand complaints that I have filed to highlight and ultimately fix the significant shortcomings associated with the agency responsible for administering our state's campaign finance laws.

What are these shortcomings?

Overcomplicated and outdated requirements that are difficult to understand and comply with. Failure to properly educate the regulated community about the tasks they must perform to remain in compliance with applicable requirements and avoid complaints. Failure of the agency to send regular reminders to filers about pending deadlines. A failure to proactively enforce applicable requirements which enables the complaint system to become weaponized. Non-intuitive, non-user friendly, and buggy reporting software. Failure to meaningfully enforce core requirements. Failure to follow the best operating practices of other neighboring campaign finance agencies. An agency leadership structure that largely disregards stakeholder input and is slow to identify and resolve major agency deficiencies.

I believe that the best way to motivate the agency to address these problems is by filing a large number of complaints so that the agency's problems become impossible to ignore.

We identify gaps in our movement's infrastructure and work to fill them, pursuing opportunities and addressing threats that stand in our way of success. We focus on the health of the state's progressive movement across multiple issue areas and over time — it is no one else's job to tend to this underlying foundation.

Impact

Move Money



*We organize donors as critical actors in our movement to give in a strategically aligned way, pooling resources to make grant investments in the organizations and initiatives working for a healthy democracy and racial, gender, economic, and environmental justice.*

**Grantmaking:** Since our founding we have granted over \$15 million from our pooled fund, and stewarded over \$6 million in additional restricted funds to key programs.

**Launching new capacities:** We have provided seed funding and support to help launch more than 10 new programs and organizations with focuses ranging from data infrastructure, to candidate recruitment and support, to narrative development, to organizing young people in politics.

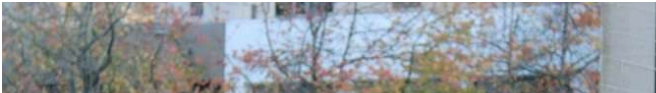
**Aligning funding:** We collaborate with individual and institutional funders to co-fund emerging opportunities. In prior years we have helped to organize up to \$600,000 of additional funds to key priorities.

**Organizing donors:** We unite our community of donors behind a shared vision and membership philosophy, and host several educational events per year to ground us in our values, desired outcomes, and strategies.
