To Whom It May Concern:

According to the Washington Administrative Code (WAC) 390-16-042(d):

*Provided that the amount of the debt or obligation in (a), (b), or (c) of this subsection owed to a vendor is more than \$1,000, and the vendor has not been paid in full for the goods received, invoices submitted, or services performed within the time periods specified below:*

*(i) For reports due within 30 days of an election, debts or obligations of more than \$1,000 must be reported if the debt or obligation has been outstanding for more than five business days as of the last day of the reporting period.*

*(ii) For reports due during any other reporting period, debts or obligations of more than \$1,000 must be reported if the debt or obligation has been outstanding for more than 10 business days as of the last day of the reporting period.*

A small amount of yard signs (50) was ordered in late April 2025. The cost of the order was \$628.14, which is below the \$1,000 threshold for reporting as a debt or obligation according to the rules stated above. The order was not paid for until June 2025, the reporting period for which has not yet ended, so the expenditure has not yet been reported and is not due to be reported until July 10. We are and will always strive to remain in full compliance of the law.
