Dear Ms. Hansen,

Thank you for reaching out regarding the recent complaint regarding case no. 174702. I appreciate the opportunity to respond and to ensure full compliance with PDC regulations.

Response to Allegation

Upon reviewing the complaint and the associated rules provided in your email, I immediately conducted an internal audit of our campaign signs. I confirmed that a portion of our early sign run did not include the proper sponsor identification in the required font size. This was an unintentional oversight, and I take full responsibility for the error.

Corrective Action Taken

To swiftly remedy the issue and ensure full compliance:

- **Sponsor Identification Stickers:** We produced and applied new vinyl stickers that state:

“PAID FOR BY VOTE TYLER BYRD - PO BOX 535 BELLINGHAM, WA 98227”

These stickers meet the 10% font-size requirement relative to the largest font used on the signs.

- **Sign Updates:** We began applying these stickers to existing signs immediately and have updated a significant number of signs already. I’ve attached photos for your reference showing the corrected signage.
- **Public Communication and Volunteer Engagement:** I have made public announcements at community events informing supporters of the issue and requesting that they notify the campaign if they have a sign or see one in the community missing the required disclosure. This will allow us to track and correct all signs currently in circulation.
- **Website Update:** I have also updated the footer of my campaign website (<https://www.tylerbyrd.com>) to now include our full sponsor identification and mailing address.

Commitment to Compliance

Our campaign is committed to transparency, accountability, and full adherence to all PDC rules and Washington State election laws. We appreciate the PDC's guidance and will continue to make proactive efforts to ensure no further issues arise.

Please let me know if any additional information or corrective action is needed. I will continue updating the remaining signs and will confirm once all have been corrected.

Thank you again for the opportunity to respond and correct this matter promptly.
