RE: Edwards Complaint Filed Against AIWA APC

Mr. Stutzman-

Thank you for bringing Mr. Edwards's complaint to our attention. The AIA Washington Council is committed to full compliance with all PDC regulations and shares the concern that our campaign finance disclosure system must function transparently and effectively to maintain public trust.

We want to address the timing concerns raised in this complaint. AIWA contributed to several campaigns in 2024, with each contribution properly reported to the PDC as required by law. Our process involves member engagement where our members personally deliver contribution checks to candidate groups as part of relationship-building with their legislative representatives. While this member-driven approach sometimes results in varying deposit timelines - ranging from late August through mid-October in this case - we consistently reported each contribution in accordance with PDC requirements and our established reporting schedule.

AIWA submitted all required monthly C-4 reports to the PDC on schedule, including our August, September, October, and November filings. We have retained copies of these reports along with the PDC's email confirmations of receipt, which we are providing for your review.

We recognize that campaign finance compliance can be complex, and we appreciate Mr. Edwards's dedication to ensuring the system works as intended. AIWA takes our reporting obligations seriously and will continue to work diligently to meet all PDC requirements.
