Website & Domain Registration The domain name washingtonpatriotpac.org was purchased and registered on October 15, 2024, prior to the PAC’s registration with the PDC. The site functions as a political committee platform and includes calls to action, candidate endorsements, and a direct donation portal.</p> <p>2. Late Registration and Pre-2024 Activity Washington Patriot PAC officially registered with the PDC on October 23, 2024, as a full-reporting political committee. However, its website clearly suggests it had been operating and influencing elections as early as 2023, as noted by the statement:</p> <p>"Here are some of our recently elected Candidates:"</p> <p>Immediately below that, the PAC features and names Victor Lombardi, who has only ever been elected to public office once, in 2023. This representation indicates that the PAC was either:</p> <p>Functioning in 2023 in support of candidates prior to its PDC registration, or Misrepresenting its level of involvement in past elections</p> <p>Either scenario would constitute a potential violation of RCW 42.17A.205 (registration requirement) and RCW 42.17A.235 (reporting of contributions and expenditures).</p> <p>3. Failure to Disclose Support by Candidate Victor Lombardi While the PAC’s website claims Mr. Lombardi as a “recently elected candidate” associated with its activities, Mr. Lombardi’s 2023 campaign filings do not reflect any donations, independent expenditures, or in-kind support from this PAC or any PAC, which may constitute a violation of:</p> <p>RCW 42.17A.240 – for failure to report contributions or coordinated expenditures WAC 390-16-205 – for failing to report in-kind contributions</p> <p>4. Failure to Include Required Website Disclosures</p>

As of the date of this complaint, <https://washingtonpatriotpac.org> does not contain any of the legally required disclosures under RCW 42.17A.320, including:

The name and address of the sponsor

The name of the treasurer

The required disclaimer language:

“Paid for by Washington Patriot PAC, [address], [treasurer name]. Not authorized by any candidate or candidate’s committee.”

There is also no disclosure of the top five contributors to the PAC, even though the PAC spent \$3,775.08 on or before May 6, 2024, which triggers the disclosure requirement.

The donation portal, hosted by Anedot, also fails to include any sponsor ID or disclaimer.

5. Failure to Report Website and Domain-Related Expenditures

Based on PDC filings, Washington Patriot PAC has not reported any costs related to:

Domain name purchase (registered October 15, 2024)

Website development

Hosting or platform services

Anedot integration/setup fees

This appears to be a violation of RCW 42.17A.235 and WAC 390-16-037, which require full and timely reporting of all expenditures related to the committee’s operations, including digital infrastructure.

What impact does the alleged violation(s) have on the public?

The alleged violations undermine transparency and accountability in Washington's elections. When a political committee fails to properly register, disclose financial contributions and expenditures, or accurately represent its activities, it deprives the public of critical information needed to make informed voting decisions. It also creates an uneven playing field, where some groups follow the law and others do not. These actions erode public trust in the electoral process, increase the risk of undue influence, and make it harder to detect improper coordination or dark money in campaigns.

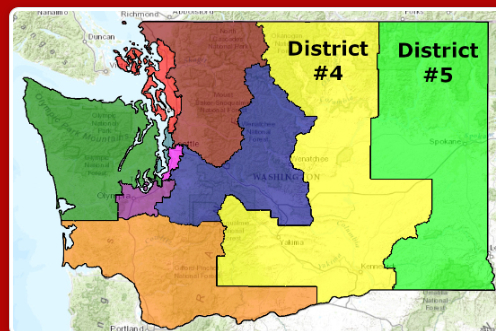
