Subject: Complaint regarding Carolyn Cox, PDC Case 23475

Dear Anthony Wallace:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on July 13, 2017. Your complaint alleged that Carolyn Cox, a 2017 candidate for Lacey City Council, may have violated RCW 42.17A.320 for failure to disclose sponsor identification on the candidate's website.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; and the response provided by Carolyn Cox to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- The complaint was filed with an archived version of the candidate's website, clearly displaying that the website was paid for by Choose Carolyn Cox, the candidate's authorized committee, along with the address of the sponsor as required by RCW 42.17A.320.

Based on these findings staff has determined that, in this instance, no evidence supports a finding of an actual violation warranting further investigation.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
